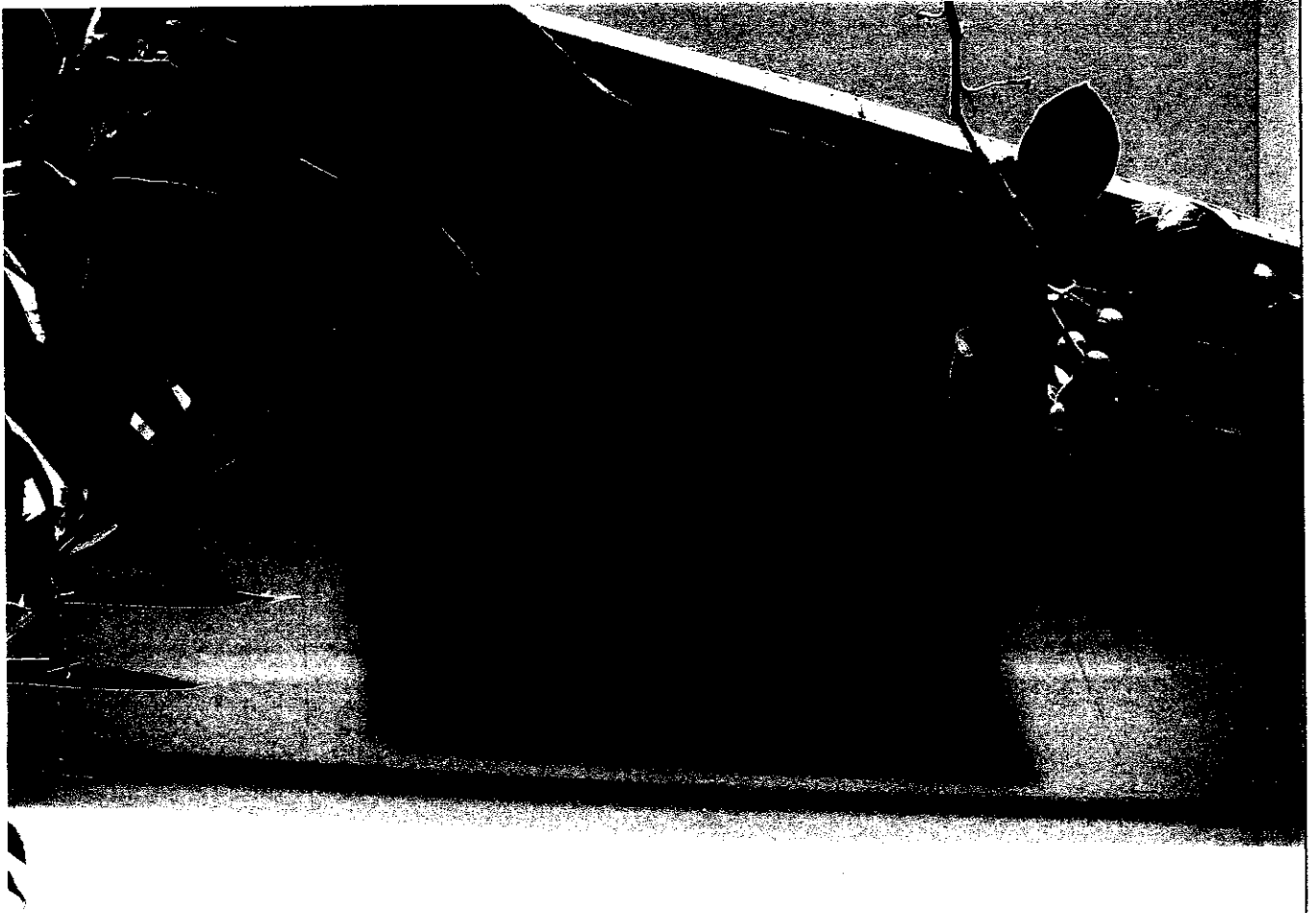


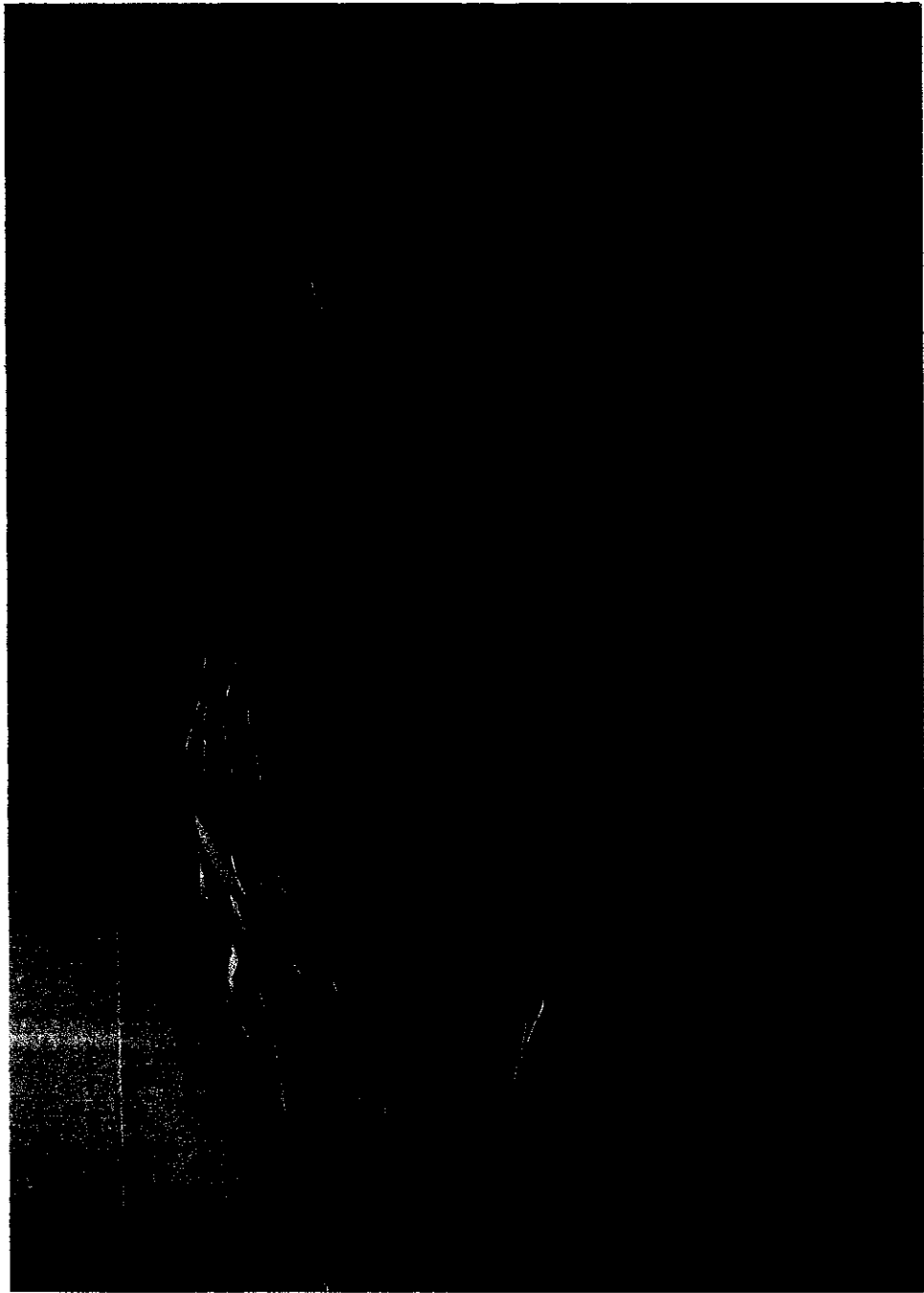

The other neighbor who joined in feeding the pigeons, shall be referred to as Pigeon Feeder #2.

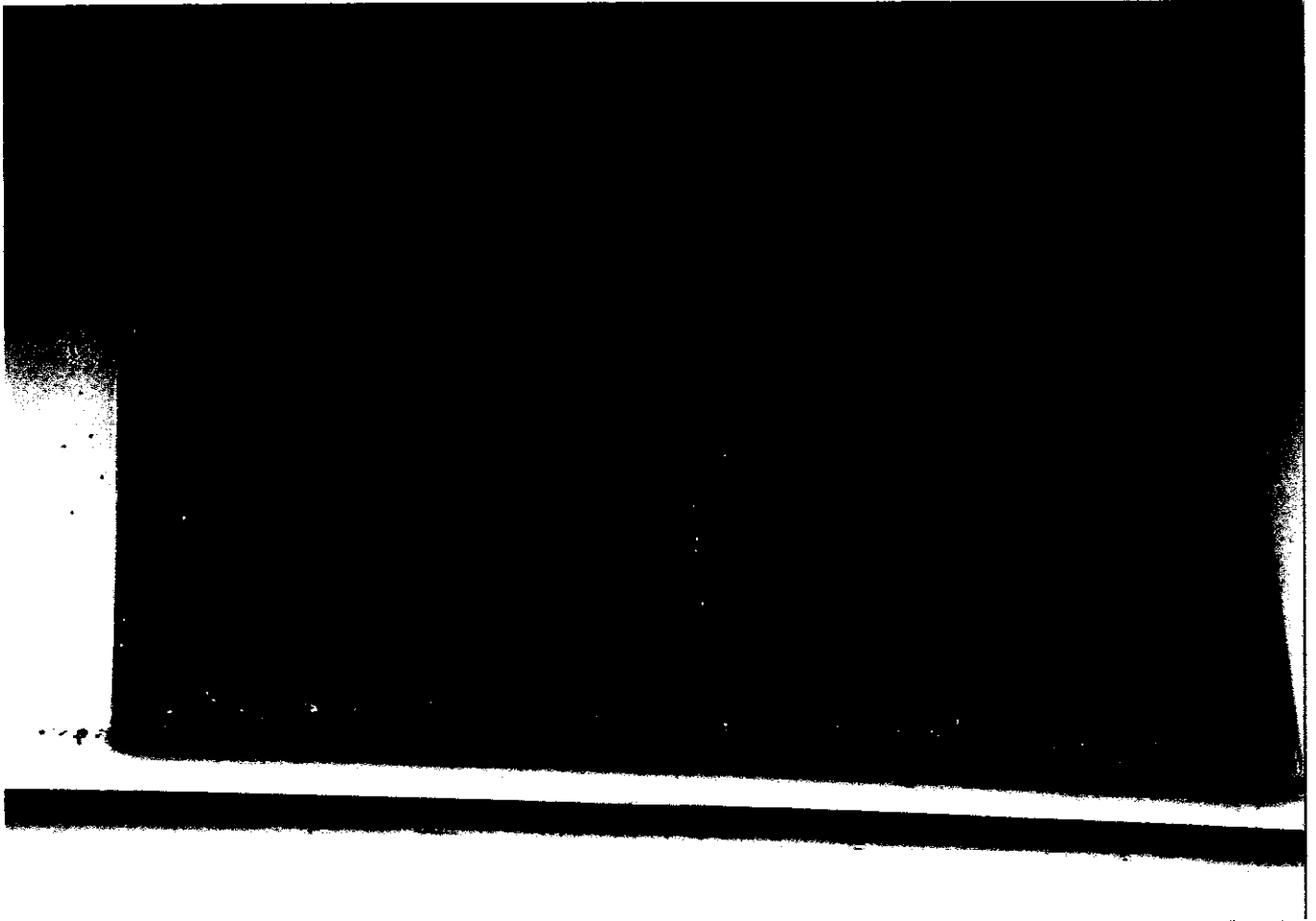

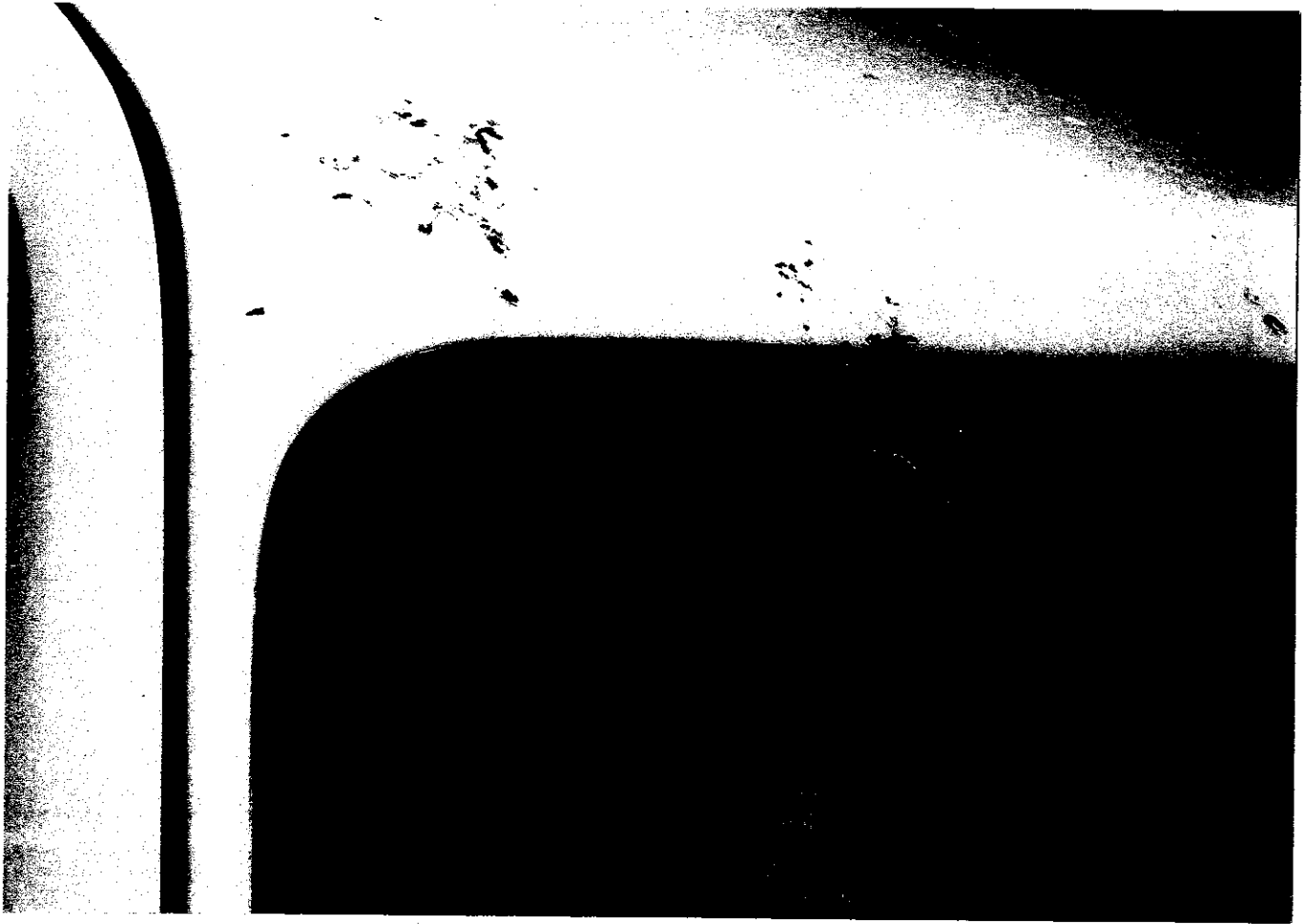

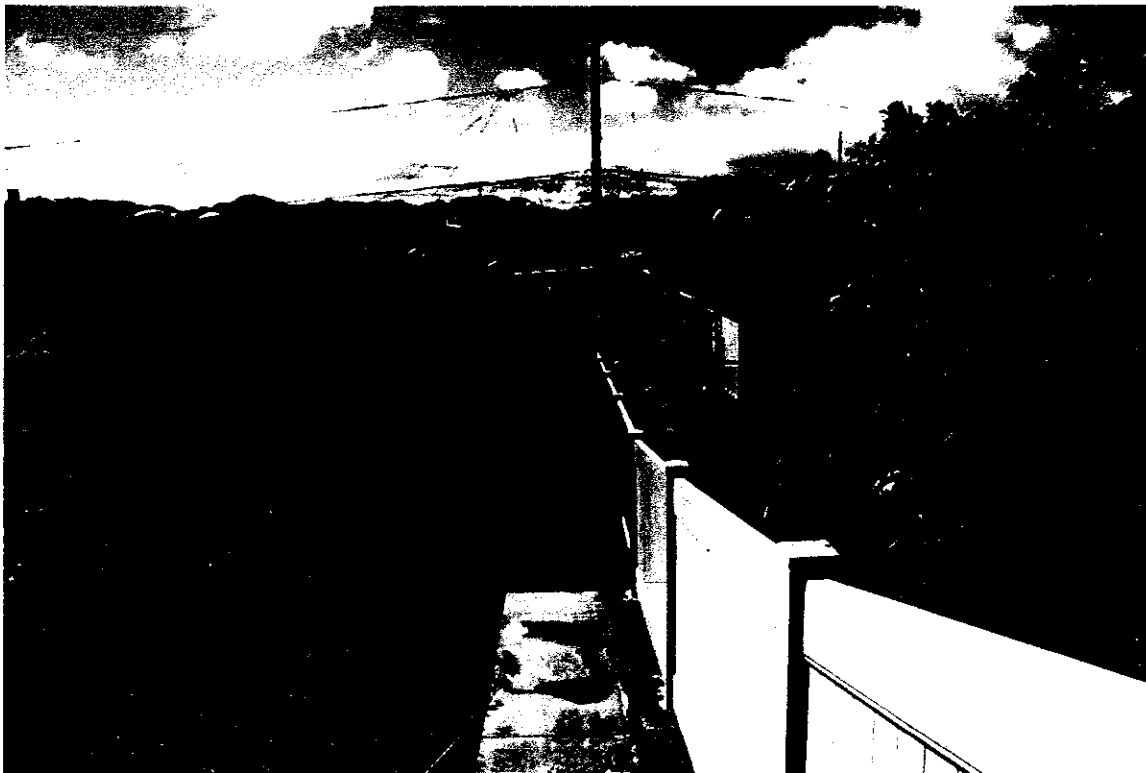

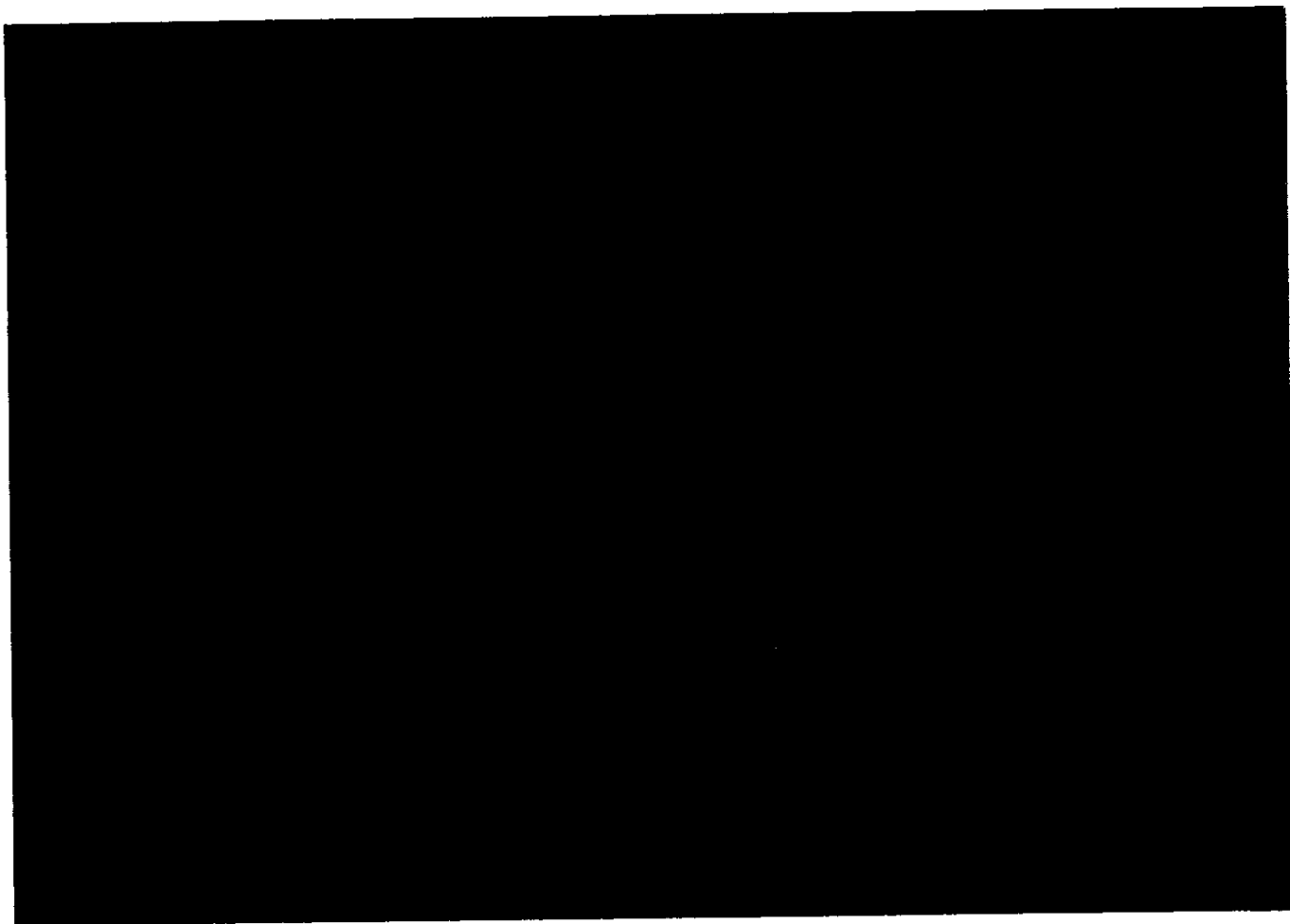

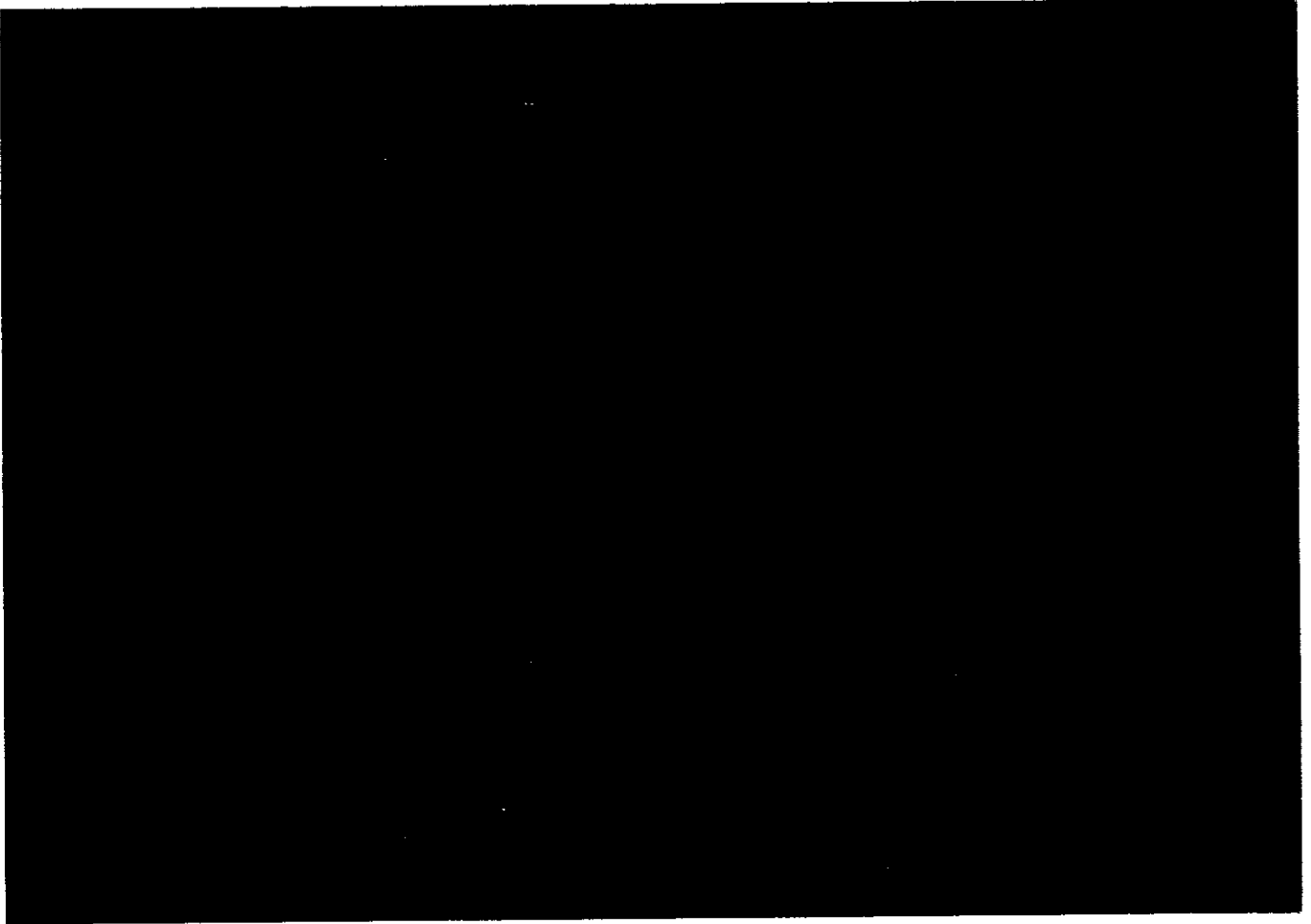
