**Re: HB 373 – Dense Breast Tissue Notification**

Dear Senators Green and Baker and Members of the Senate Committee on Health:

On Behalf of the Board of Directors of Are You Dense Advocacy, Inc., which represents the 45,000 women each year in the United States with “normal” mammography reports yet have **hidden invasive cancer** because of their dense breast tissue, I write to voice our **support of HB 373 and ask that this correspondence be included in the record.**

In 2004, I was diagnosed with advanced **stage 3C breast cancer after a decade of ‘normal’ mammograms**. I learned about my dense breast tissue risk **after** my cancer diagnosis, which was within weeks of my “happy gram” report, which stated that the results of my mammogram were “normal.” My surgeon informed me that my **years of mammography screening failed to detect my cancer because of my dense breast tissue.**

I was shocked to find out that my story, while compelling, is common as 40% of women have dense breast tissue. **Breast density is the strongest predictor of the failure of mammography screening to detect cancer.** However, **less than one in 10 women learn about their breast density** from their physician. For more than two decades, research demonstrates that women with dense breast tissue **have a 50% chance of having their cancer detected** by mammography alone. As density increases, the sensitivity of a mammogram to “see” cancer decreases. **Dense Breast Tissue is also a well-established predictor of breast cancer risk** – its relative risk is greater than a woman having TWO first-degree relatives with breast cancer.

Armed with these startling facts, I started working with the CT legislature and in 2009, Connecticut became the **first state in the nation to standardize the communication of breast density** to women through their mammography report. The state of **Texas passed similar legislation in 2011; followed by Virginia, New York and California in 2012.** Presently, **12 states, including Hawaii,** are introducing notification bills in 2013.

We commend the leadership of Representatives Yamane, Aquino & Cullen for bringing **this critical health issue** to the committee. Decades of studies have concluded that the size of a breast tumor upon discovery is a fundamental determinant of mortality. Women of Hawaii with dense breast tissue are one of Hawaii’s most vulnerable citizens and need protection from advanced stage cancer. **How can women advocate for their breast health when information about their breast composition, which may result in delayed diagnosis and poorer survival outcomes, is not shared with them?**

HB **373** will give women of Hawaii information about their dense breast tissue **so they can be informed participants** in discussions with their health care providers about their personalized breast screening program. HB 373 **will lead to a reduction in later stage cancers, less aggressive treatments and better life outcomes** for Hawaii women.

Comments: My wife is a breast cancer survivor who, before her radical mastectomy, had very dense breast tissue. She religiously scheduled and received her annual mammograms to detect breast cancer. Well, the mammograms alone did not detect her breast cancer tumor, and she was blissfully ignorant to the cancer growing inside of her due to dense breast tissue. It is by chance alone that her tumor was finally discovered and diagnosed. Had she known earlier that dense breast tissue made it extremely difficult to detect and identify tumors, she would have requested additional testing and subsequently would have discovered her cancer sooner. I have five sisters; two of which work in the nursing field, and none of them knew that dense breast tissue could easily mask a cancer tumor during routine mammograms that other testing could more easily identify. I believe that this bill is a stepping stone to increased awareness about the shortfalls to mammogram testing in women with dense breast tissue. And, if passed, it will save thousands, if not hundreds of thousands of men and women affected by this deadly form of cancer, by educating them to get additional testing and subsequently diagnosing them earlier before it invades their bodies further.
