Attention: House Committee on Consumer Protection and Commerce,

1. The purpose of this letter is to support the initiative to require licensure for Physical Therapy Assistants in Hawaii. This letter was originally sent to HAPTA and State Board on August 20, 2012. Due to recent political developments this is in support of House Bill 843, to require licensure for Hawaii Physical Therapy Assistants.
2. Hawaii will soon be the only state that does not require a license to practice at a professional level (Colorado is pending a licensure requirement for 2014).
3. The licensure requirement provides a level of credibility that goes beyond a training program certification.
4. The U. S. Army is pending a decision to no longer accept job applications from PTAs who are not licensed. This will mean that PTAs who are trained in Hawaii will not be able to compete for jobs in Hawaii unless they sit for the licensure exam for another state.
5. In addition to licensure it is strongly recommended that continuing educational requirements are included as part of the renewal process.
6. Any opinion expressed in this letter is mine and may not reflect the official position of the Army or Tripler Army Medical Center.
