<u>PURPOSE</u>: The purpose of H.B. 877, H.D. 1, is to allow the directors of the Departments of Commerce and Consumer Affairs, of Health, of Human Services, and of Labor and Industrial Relations to delegate voting authority to their designees for all meetings.

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) strongly supports this Administration bill. The DHS strongly recommends, however, that the original language of the bill be reinstated.

The H.D. 1 amendment to this bill makes it unclear as to which meetings the designee will be attending. The language as amended in the H.D. 1 on page 1, line 14 that "...labor and industrial relations may select a designee from their respective departments for all meetings" seems to indicate that the designee must attend all the meetings not just AN EQUAL OPPORTUNITY AGENCY

for "a specified meeting or meetings" as proposed in the original bill. The DHS requests that the original language of the bill be reinstated for clarity.

We also concur with the Department of Labor and Industrial Relations that the department directors should have the flexibility to assign more than one designee depending on the availability of staff.

The successful operation of the Hawaii Health Connector will allow Hawaii's resident to take full advantage of the Affordable Health Care Act benefits and will ensure a seamless integration with the Department of Human Services' medical assistance programs.

Act 205, Session Laws of Hawaii 2011, codified as chapter 435H, Hawaii Revised Statutes, established the Hawaii Health Insurance Exchange as a Hawaii nonprofit corporation. The corporation is also known as the Hawaii Health Connector. Section 435H-4(b), Hawaii Revised Statutes, specifies that the directors of the Departments of Commerce and Consumer Affairs, of Health, of Human Services, and of Labor and Industrial Relations or their respective designees shall be ex-officio voting members of the board of directors of the Hawaii Health Insurance Exchange.

Allowing the directors of the named departments to select a designee for specified meeting or meetings will ensure the voting representation that is critical for the successful development and implementation of the Hawaii Health Insurance Exchange. Also, a voting quorum may not be met without the directors' designees.

The implementation of a health insurance exchange is necessary for meeting the requirements of the federal Affordable Health Care Act.

#### I. OVERVIEW OF PROPOSED LEGISLATION

This measure allows the directors of the Departments of Commerce and Consumer Affairs, of Health, of Human Services, and of Labor and Industrial Relations to select a designee for all Hawaii Health Connector meetings.

The department <u>strongly supports</u> this proposal and respectfully requests a minor amendment.

#### II. CURRENT LAW

The Director of Labor and Industrial Relations (DLIR), or the director's designee, is an exofficio, voting member of the Board as so specified under Act 205 of 2011 (codified as Hawaii Revised Statute Chapter 435).

#### III. COMMENTS ON THE HOUSE BILL

The proposal allows the Director to voice his vote through his designee when he is unable to attend the meetings of the Board of Directors. Board meetings may be scheduled on very short notice and the Director may not always be available given his daily responsibilities. The Director's designee with voting privileges, furthermore, will count towards constituting a quorum and will facilitate the transactions of the Board or committee

in a timely manner.

The Department is concerned whether the proposal allows the Director to appoint another designee if the assigned designee is unable to attend a meeting for the Director. The Department recommends that to make clear that other designees may be assigned by the Director, the following revision be made to the proposal on line 13 of page 1: (deleted text is bracketed and lined out, added text is underscored)

"...labor and industrial relations may each select [a] designees from..."
