Chair Wakai and members of the Committee, I am Eva Laird Smith, executive director of the State Foundation on Culture and the Arts. I am pleased to support House Concurrent Resolution 116, provided its passage does not replace or adversely impact priorities indicated in the Executive Budget.

The State Foundation on Culture and the Arts opened the Hawai'i State Art Museum in 2002 to house and display the Art in Public Places Art Collection, which was created in the name of the people of Hawai'i. Since then, we have striven to share Hawaii's history and culture with our residents and visitors through exhibits, loans of art, and providing educational programming for intergenerational audiences developed around the Collection.

Today, HiSAM exhibitions at any given time are free to the public and accessible to all visitors. We have hosted thousands of public and private school students in our brief history and have worked with many of them in our Art Bento Program, which provides hands-on art workshops in a variety of media. This fulfills two priorities of our strategic plan, which encourages the progression of arts education for our children and youth through innovative programming provided by our museum.

Every year, the State Foundation also hosts the Scholastic Art Exhibition at HiSAM, giving students a rare opportunity to enter an art competition and for their work to be seen in a quality venue. Other activities for youth include an exhibit of student art at the Hawai'i Convention Center and a series called "Second Saturday," that provides art experiences at HiSAM for families.

Most assuredly, as the museum develops, we can do more. In the coming months, we will be addressing a new strategic plan and will introduce new programs to be developed for the youth of Hawai'i.

Thank you for your continued support of our programs on behalf of educating the children and youth of Hawai'i and for the opportunity to testify on this matter.
