Two of the four counties (four of the six islands) of our State are served by Emergency Medical Service responders that are employed by private companies. They are not city, county, state or federal employees. Furthermore, the states fix wing aeromedical services are all staffed by providers of private companies. There have been line of duty deaths with these providers that would not be recognized according to HCR 34's language.
