EXISTING SEAWALL AND REVETMENT**

House Concurrent Resolution 46 requests the authorization to issue a term, non-exclusive easement covering 1,268 square feet, more or less, portion of state submerged lands fronting the property identified as tax map key: (1) 4-3-005: seaward of 056, at Lanikai, Koolauoko, Oahu for maintenance and repair of existing seawall and revetment constructed thereon, pursuant to Section 171-53, Hawaii Revised Statutes (HRS). **The Department of Land and Natural Resources (Department) supports this concurrent resolution.**

The subject seawall and revetment encroachments were discovered during the due diligence by the current owner, Mr. & Mrs. James Duncan, who were planning on listing the property for sale. The Office of Conservation and Coastal Lands has determined that removal of the encroachment will likely accelerate the loss of beach resources at the subject location. As required by Section 171-53, HRS, the Board of Land and Natural Resources (Board) may lease submerged lands "with the prior approval of the governor and the prior authorization of the legislature by concurrent resolution". At its meeting on January 13, 2012, under agenda item D-17, the Board approved the issuance of a term, non-exclusive easement.

The Department hired the appraisal firm of Appraisal Hawaii Inc. who determined the one-time payment, fair market value of the easement is \$85,000.
