Thank you for the opportunity to provide testimony in support of HCR 92, Declaring March as Localicious Hawaii month. My name is Denise Hayashi Yamaguchi and I am the Executive Director of the Hawaii Agricultural Foundation.

The Hawaii Agricultural Foundation (HAF) supports HCR 92 which declares March as Localicious Hawaii month. The resolution supports HAF's efforts to recognize local restaurants that are committed to buying local while also raising funds to support future farmers in Hawaii.
