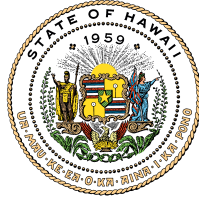

RELATING TO THE ACCESS HAWAII COMMITTEE

Chair Wakai, Vice Chair Nishihara and members of the committee, thank you for the opportunity to testify on S.B. 1000. My name is Sanjeev "Sonny" Bhagowalia, Chief Information Officer for the State of Hawaii.

The Office of Information Management and Technology (OIMT) strongly supports S.B. 1000, which designates the Chief Information Officer as the chair of the Access Hawaii Committee (ACH).

When the Access Hawaii Committee was first established the State did not yet have a full-time chief information officer (CIO) to provide the overall direction and vision for information technology (IT). Hawaii Revised Statutes §27-43 establishes the role, responsibilities and authorities of the chief information officer. The ACH provides oversight to the State's portal manager, whose duties include developing an annual strategic plan, managing all charges to portal users, negotiation of service level agreements, and conducting annual customer satisfaction. These duties fall under the purview of the CIO and are being addressed in the Business and Information Technology/Information Resource Management (IT/IRM) Transformation Plan. As such, having the CIO serve on and chair the ACH will align it to the State's IT strategic vision.

We respectfully request that this Committee move this bill forward. Thank you for the opportunity to testify on this matter.

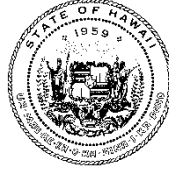

Bill No. and Title: Senate Bill No. 1000, Relating to the Access Hawaii Committee

Purpose: Designates the Chief Information Officer or the Chief Information Officer's designee to serve on and chair the Access Hawaii Committee. Effective upon approval.

Judiciary's Position:

The Judiciary supports this bill. The Access Hawaii Committee provides oversight of the State's web portal manager, which is currently contracted to the Hawaii Information Consortium (HIC). HIC is allowed to contract with any state agency to provide web services both transactional and free. Over the past twelve years in partnership with state agencies the portal manager has grown in size and now provides a significant proportion of the State's web services. As a member and chairman of the Access Hawaii Committee, the State's chief information officer (CIO) will be able to provide information on the statewide information technology initiatives and assist with the alignment and prioritization of these initiatives with the portal manager's initiatives.

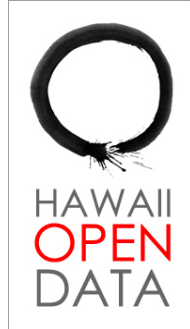

I am Burt Lum, Executive Director of Hawaii Open Data, a non-profit dedicated to advancing open data principles in Hawaii. Formed in 2012, we focus on improving data accessibility and integrity in support of public/private collaboration, government transparency and civic engagement.

Hawaii Open Data **supports SB 1000, Relating to the Access Hawaii Committee, with comments.** SB 1000 amends §27G-3 to designate the Chief Information Officer or the Chief Information Officer's designee to serve on and chair the Access Hawaii Committee. This is a measure to account for the new State CIO position.

We would also like to amend §27G with the following verbiage to add a public voice to the committee and increase transparency in the management of the State's web portal:

1. Amend §27G-3 to include a member of the public appointed by the Governor's office to sit on the Access Hawaii Committee
2. Amend §27G-5 to make the portal manager's annual financial reports to be a requirement of the annual report to the legislature and public.
