TESTIMONY IN OPPOSITION TO SB 1027

Aloha Chair Ige and Members of the Committee:

The Sierra Club, Hawai'i Chapter, with 10,000 dues-paying members and supporters, respectfully *opposes* SB 1027. This measure would put the state in charge of authorizing its own Coastal Zone Management permits without the substantive safeguards built into the existing law.

As a preliminary matter, we note that we submitted testimony in opposition to this bill in the subject matter committee. This is not recorded in the Committee Report or in the testimony record.

Turning to the language of the measure, this bill puts the proverbial fox in charge of the hen house. Consider that the Office of Planning would:

- Have no obligation to hold a public hearing or meet with neighbor island residents;
- Be able to “consider” public comments, but have no consequences for ignoring them;
- Have no enforcement capacity, no administrative process for violations, or clear ability to levy fines under Chapter 205A;
- Be allowed to ignore the county-established setback laws;
- Have the authority to make decisions without an environmental review having been completed; and
- Eliminates the counties from substantively reviewing major projects that impact their own infrastructure and long-range plans.

Existing law protecting Hawaii's fragile coastline should not be weakened. The special management area process—while it could be improved—works to protect Hawaii's coastal zone area by ensuring public input and environmental oversight. Exempting the State from a carefully thought-out process that has a cumulative or significant impact on the coastal zone area does not make sense, especially when Hawaii's coastal areas are a primary attribute attracting visitors to the state.

Comments: Aloha Chair Ige and committee members. Attached is a photo of a mud plume that occurred last August along the west Maui shoreline. It was the result of a "fast tracked" state DOT road repair project that had no SMA review. It was, however subject to some sort of state determined administrative review, but the Maui county coastal zoning planning experts were never included in the loop. As a result, the project contractors were informed that there were no viable reef systems offshore of the roadwork project. Our County CZM specialist would have given the contractors accurate info about the reef and suggested mitigating actions for the project during the SMA review. The Planning Commission member from West Maui could have given first hand knowledge of the area. Unfortunately, all this knowledge was bypassed. The project contractors exposed a layer of red clay as they dug back the road edge. In a few days, the natural wave action turned the exposed clay into a plume of silt that discolored the ocean and coated the reef (that actually did exist right offshore,) with a silty layer that can affect the living coral's ability to take in light. I have attached pictures of the plume and the reef. Please do not support this bill. The SMA process, may not be perfect, but it is better than the kind of administrative review that is proposed for state protects in this Bill, and was exercised in this HDOT road project in West Maui will not protect the resources we hold in trust for future generations. By the way, I live in an SMA zone and have applied for various SMA permits. Mahalo Lucienne de Naie, Huelo, Maui
