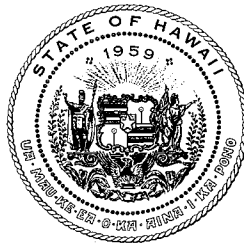

I am Jan Yamane, Acting State Auditor. Thank you for this opportunity to comment on Senate Bill No. 1082, relating to transportation of school children. We appreciate reference in this bill to our Report No. 12-07, *Management Audit of the Department of Education's School Bus Transportation Services*, in which we found that ineffective and unsystematic management of student bus services has resulted in spiraling costs.

Although our recommendations did not include amendments to the Department of Education's statutory provisions, we appreciate the Legislature's initiative to improve the department's student bus service contracting process by way of this bill.
