Chairs Dela Cruz and Galuteria, and Members of the Committees:

The Department of the Attorney General testifies to convey its concerns about this bill. We previously shared some of these concerns with several individual members of the Senate who inquired about various aspects of this bill.

This bill by its express terms “establishe[s] the Native Hawaiian corporation, which shall be a body corporate and a public instrumentality of the State,” separate from the Hawaiian Homes Commission (HHC) but administratively attached to the Department of Hawaiian Homes Lands (DHHL), “for the purpose of receiving and managing”

- “[A]vailable lands’ [as they are described] in section 203 of the Hawaiian Homes Commission Act, 1920, as amended” [(HHCA)];
- “[L]ands conveyed to the State pursuant to section 5(f) of the Admission Act Section 5(f)” or “ceded lands;” and
- “Any other lands to which Native Hawaiians and Hawaiians may be entitled for the benefit of Native Hawaiians.”

Page 1, lines 10-18. Nothing in this bill indicates when or how these lands will be transferred to the new state agency, or for what purpose the lands the agency receives are to be held and managed. There are also no provisions in this bill to staff, equip, or house the new state agency, or to cloak it with authority or powers to manage the lands it receives. Finally, this bill says nothing about what is to happen to the HHCA, the HHC, the DHHL, or to the Land Division of

the Department of Land and Natural Resources, after the “available lands,” presently the principal asset with which the HHC and DHHL implement the HHCA, and the “ceded lands,” which constitute more than 90 percent of the State’s other landholdings, are transferred to the new state agency.

1. Nothing in the bill’s text suggests that the subject of the bill is “Economic Development.” Article III, section 14 of the State Constitution provides in pertinent part: “Each law shall embrace but one subject, which shall be expressed in its title.” A court could conclude that this bill does not satisfy this constitutional requirement. Moreover, because the bill that establishes the new state agency neither details nor limits how the land is to be received or managed by the agency, a court could conclude that the agency was not endowed with sufficient powers to manage the State’s lands at all. See article XI, section 2 of the State Constitution.

2. This bill appears to assume that the “available lands,” i.e., the lands with which DHHL presently implements the HHCA, can and will be transferred to the new state agency. As long as the HHCA is not repealed, however, those lands will be needed for that purpose, and the HHC will continue to have exclusive authority to use and manage them. See section 204 of the HHCA. Further, the HHCA can only be repealed if the Legislature repeals the Act, **and** the United States Department of Interior and the United States Congress consent to the repeal. Any transfer of such lands without consent from the Department of the Interior and Congress would likely be illegal.

3. If the Legislature unilaterally transferred the lands to the new entity and the HHC and DHHL were no longer able to fulfill the requirements of the HHCA, the State could be found to have violated section 4 of the Admission Act, and the covenant the State entered into with the United States when the voters of Hawaii ratified the Admission Act.

4. The “ceded lands” represent more than 90 percent of all the lands to which the State and its departments, agencies, and instrumentalities hold title. If these lands were transferred or “received” by the new entity, it is unclear how the entity would manage the lands. If the lands were put solely to the use of a Native Hawaiian entity, an issue would be raised as to whether the other four purposes for which section 5(f) lands are designated were being fulfilled.

5. Finally, this bill also refers to “[a]ny other lands to which Native Hawaiians and Hawaiians may be entitled for the benefit of Native Hawaiians.” It is unclear to what lands this

refers. However, because some in the community have claimed that all lands in Hawaii were illegally taken and thus do not belong to the State, this last provision could be misconstrued to be a reference to all land in Hawaii. Without further details, this last provision of the bill could suggest to some that the bill anticipates transfers of private lands to the new entity.

Until these concerns are addressed, and more details are included in the bill to describe the purpose, objectives, powers, and functions of the new entity it creates, the Department of the Attorney General recommends that this bill be held.

Chair Dela Cruz, Chair Galuteria, and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) offers the following comments on this measure. This bill proposes to create a public corporation to be attached to the Department of Hawaiian Home Lands, that shall have the purpose of receiving and managing select public lands collectively referred to as Native Hawaiian lands, including public lands designated as "available lands" under section 203 of the Hawaiian Homes Commission Act.

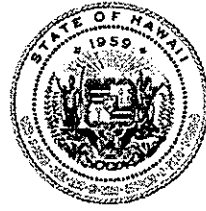
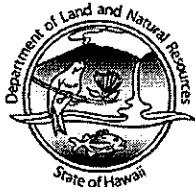
While an attached public corporation may provide the department with a potential vehicle to pursue revenue production for its programs on other public lands as well as on Hawaiian home lands, given the current language of the bill it is not clear if this is what is intended by this measure. Additional detail regarding the corporation's purpose, its powers, and guidance on the relationship between the corporation and the Hawaiian Homes Commission would reduce ambiguity and would clarify the legislative intent of this bill.

Further, the bill amends the Hawaiian Homes Commission Act, 1920, so we conclude that these lands are to be managed for the benefit of native Hawaiians as defined by the Act. We also conclude that any revenue generated by the corporation would be deposited and expended pursuant to Section 213 of the Act. While the intent related to these two points is not clear in this bill, any departure from these conclusions would raise serious concerns.

As we face the end of the \$30 million annual settlement funding for DHHL and tight budgets at both the state and federal level, finding new sources of revenue for DHHL can be achieved if we are willing to think out of the box and consider all options, like this legislation. However, because the devil is always in the detail, we must also proceed conscientiously and thoughtfully, and fully vet any new ideas to ensure long-term success. In addition, a proposal such as this which could have far reaching implications for our department and the trust would require that our department engage in dialogue and consultation with our beneficiaries to seek their input and feedback as to whether they feel the corporation proposed by this bill is beneficial.

Senate Bill 123, Senate Draft 1 proposes to amend the Hawaiian Homes Commission Act, 1920, as amended, to establish a Native Hawaiian corporation under the Department of Hawaiian Homelands ("DHHL") to manage "available lands" under the Hawaiian Homes Commission Act, "ceded lands" under the Admissions Act, and other lands to which Native Hawaiians and Hawaiians may be entitled, to be referred to collectively as "Native Hawaiian lands." **The Department of Land and Natural Resources (Department) respectfully opposes this measure to the extent it is intended to ultimately transfer the fee simple interest and management jurisdiction of the State's entire ceded lands inventory over to the Native Hawaiian Corporation.**

The Department notes that of the 1.3 million acres under the State's ownership that is held and managed by the Department and Board of Land and Natural Resources, over 97% are classified as ceded, which includes lands being used for airports, harbors, public schools, the University of Hawaii, shoreline and coastal areas, forest reserves, parks, etc. The Department respectfully submits that there is a fiduciary duty to manage these public trust lands for the benefit of all of the people of the State of Hawaii. The Department does not believe it would be in the best interest of the State or the people of Hawaii to combine two public land trusts with different missions and beneficiaries for policy, legal, and constitutional reasons.
