- 1 **Department's Position:** The Department of Health (DOH) supports the intent of this bill but it is not
- 2 necessary at this time.
- 3 Fiscal Implications: Currently, the Hawaii Certified Peer Specialist (HCPS) program is funded through
- 4 the Trauma-Informed Care Initiative (TIC-IT) Federal Grant from the Substance Abuse and Mental
- 5 Health Services Administration. Following the conclusion of the grant in 2015, the Adult Mental Health
- 6 Division (AMHD) may seek funding to support and sustain this program.
- 7 Purpose and Justification: This bill seeks funds to support the AMHD HCPS Initiative. Through the
- 8 TIC-IT grant, Hawaii has been able to fund certified peer specialist training.
- 9 At the end of the grant funding, AMHD anticipates continuing its commitment to the program.
- 10 After the conclusion of the grant, funds may be requested from the legislature for continuation of the
- 11 certified peer specialist training.
- 12 As we improve the integration of our of certified peer specialists' activities, the department will
- 13 continue to work with key stakeholders in this critical area of performance.

GOOD MORNING CHAIR GREEN, VICE CHAIR BAKER AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide hui of more than twenty non-profit treatment and prevention agencies.

Because of their life experiences with mental illness and mental health services, the peer specialists provide expertise that professional training cannot replicate. They help the recovering person gain confidence in decision-making and promote a culture of self-help rehabilitation.

Peer specialists improve outcomes and reduce decompensating conditions that can be costly.

Healthcare reform has worked in those states that did "invest" in chronic care to stabilize what can be very costly conditions followed by systems of care that would encourage self-help responsibility to manage their conditions. Peer specialists are an essential key for developing prevention type strategies that promote individual responsibility that would help reduce the upward spiraling costs of healthcare.
