- 1 Department's Position: The Department of Health (DOH) supports the intent of this bill.
- 2 Purpose and Justification: The bill changes the term "police officers" to "law enforcement officers,"
- 3 to be consistent with Section 710-1000 of Hawaii Revised Statutes (HRS) 334-1. The recommended
- 4 change improves HRS 334-59 and is an integral part of an ongoing need for individual mental health
- 5 supports at all levels of intervention.

Chairs Green and Espero, Vice Chair Baker and Members of the Committees:

The Department of Public Safety (PSD) supports Senate Bill 44, which expands Section 334, relating to mental health, mental illness, drug addiction, and alcoholism, to apply to all law enforcement officers as defined under Section 710-1000, which includes any public servant, whether employed by the State or subdivisions thereof, or by the United States, vested by law with a duty to maintain public order, or to make arrests for offenses, or to enforce the criminal laws, whether that duty extends to all offenses or is limited to a specific class of offenses. Currently, Section 334 applies only to the county police, and this amendment would allow all law enforcement officers and not just county police are able to utilize Section 334-59, HRS. This section presently allows the

police to contact the mental health emergency workers designated by the Director of Health to make a professional determination if an individual may be a danger to self or others, or is gravely disabled, or is obviously ill, and to authorize the transport of this person to a licensed psychiatric facility for further evaluation and possible emergency hospitalization.

Thank you for the opportunity to testify on SB 44, which substitutes the language "law enforcement officer" for "police officer" as it relates to who may act in assisting, apprehending or transporting persons believed to be mentally ill for the purposes of carrying out their duty as law enforcement officers. Broadening the language will allow sheriffs who have law enforcement duties on State property to discharge their duties in support of the mental health law that affects so many persons who are homeless.
