- Department's Position: We support this bill provided that its passage does not replace or adversely
- 2 impact priorities indicated in our Executive Budget and address a revenue stream to carryout its intent.
- 3 Fiscal Implications: Appropriates funds for FY2014 and FY2015 from EMS Special Fund (ESF). The
- 4 Department is projecting a shortfall in ESF to fund existing ambulance contracts for FY2014 so could
- 5 not fund these additional services at that time. Due to increasing cigarette taxes and revenues after July
- 6 1, 2014, increased funding will be available.
- 7 **Purpose and Justification:** This measure proposes an advanced life support emergency medical
- 8 services (EMS) unit stationed at Maalaea in Maui County that can rapidly respond to 911 calls in the
- 9 surrounding areas. This location is strategically located between the communities of West and South
- Maui, overall, an area that has grown in population in the past ten years.
- Emergency response with a non-transporting rapid response EMS unit at Maalaea could
- significantly reduce the response time to serious and critical medical and trauma cases in Maui County,
- initiating early treatment and providing additional personnel for multi-victim incidents and for helicopter
- 14 transports.

Commenting in Support of SB 498 SD 2: Relating to Emergency Medical Services.

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including all acute care hospitals, a majority of home health agencies and hospices, as well as long term care facilities and other health care organizations. Our members contribute significantly to Hawaii's economy by employing nearly 20,000 people statewide, delivering quality care to the people of Hawaii.

Thank you for this opportunity to testify in support of SB 498 SD 2, which appropriates funds for a special emergency medical response vehicle unit based in Maalaea on Maui.

The population of Maui has grown rapidly in recent years, increasing at about 7% annually, with Maalaea, west Maui, and south Maui experiencing much of the growth. Only two ambulances serve the residents of these districts. The population increase has increased the call volume, which in turn has affected their timely response capabilities. A timely response to a 911 call is critical to ensure the best possible medical outcome.

The last time new emergency medical services ambulance units were added on Maui was in 2004. This bill would fund a special emergency medical response vehicle unit modeled after successful units on Oahu and the mainland. Although it would not be used for patient transport, it would provide advanced life support services to augment the basic services of fire department first responders. It is designed to stabilize patients in the crucial initial stage of injury, illness, or cardiac arrest, and ultimately save lives.

For the foregoing reasons, the Healthcare Association of Hawaii supports SB 498 SD 2.

Aside from Maalaea's strategic location at the intersection of the transit corridors between Central, South and West Maui, there is also an urgent need for an SRV in Maalaea itself. In addition to the approximately 1,000 full-time owner-occupants and visitors, many elderly, there is also the harbor with its associated boating activities, the aquarium, restaurants and shops, the Coast Guard Station, Haycraft Beach Park and its adjacent isolated beach (the site of frequent water rescues), all of which frequently require SRV responses from locations far away, when every minute counts. Regarding SB 498, Relating to Emergency Medical Services

Chair Sylvia Luke, Vice Chair Scott Nishimoto, Vice Chair Aaron Ling Johanson, and members of the Committee:

The addition of this specialized paramedic unit in Maui is literally critical. It has been nearly a decade since an EMS unit was added in Maui. In the last several years, EMS call volume has risen steadily (\sim 20%), and out-of-district responses have risen precipitously (>25%), due to scarce ambulance resources. As of this writing and as only one example, in the first 85 days of this year the paramedic unit for Kihei has been pulled out of that town to respond elsewhere in the county over 110 times. This phenomenon is repeated every day in multiple areas of the county, most notably in West, South and Central Maui.

The Special Response Vehicle (SRV) Paramedic unit would be strategically placed in Maalaea, which is precisely at the intersection of these three busiest districts. By locating the unit there, the growing community of Maalaea will have an EMS resource where there is currently none, and the SRV unit will also be available when needed for rapid provision of Advanced Life Support (ALS) in those surrounding districts of West, South, and Central Maui. This will mean that instead of having to wait 45 minutes or more for ALS as some of these patients currently do, the SRV unit will often be there to stabilize the patient within 15 minutes or less. Experts from the American Heart Association to the American College of Surgeons have recognized that early Advanced Life Support is key to life and death situations.

Notably for the consideration of the Committee on Finance, this Maalaea SRV unit represents a highly efficient and cost-effective use of resources, with estimated operating costs less than one-third the appropriation for a new ambulance in Honolulu County. With passage of this bill, the simple addition of one specialized paramedic unit will immediately translate to a much more adaptable EMS system in Maui -- and many lives will be saved as a result.

Comments: Over the past (4) years, increase in resident & visitor populations have resulted in a rise in the number of 9-1-1 calls for Emergency Medical Services in both South & West Maui districts. 2004 was the last year there were any EMS state funds appropriated for upgrades in ground ambulance services. SB #498-SD2 supports a 'special response vehicle' operation that will augment Maui EMS in a more flexible, need-specific way. • It will ADD a FASTER response to the entire Maalaea community where there is no current EMS or fire units stationed. Closest for both responses are from Wailuku + Kihei. • This unit will be able to move into (South or West) Maui districts that may have both of their respective ambulances 'on-assignments' thereby creating a FASTER paramedic response than is currently available coming from another (outside) district. • An additional Paramedic resource will be available for multi-casualty incidents 24/7 including assisting Central Maui area. The Maalaea area has increased its call volume by 64% between 2009 and 2012. Additionally, the WEST Maui Ambulance Districts have received 48% more responses that have come from ambulance units that were 'outside' this district including from Kihei, Wailea, + Central Maui. Any ambulance response from 'out-of-district' results in a LONGER response time. This roving, FIRST Response "special response vehicle" will be able to render Advanced Life Support treatment while awaiting transport. Although transport is important, being able to render IMMEDIATE life-saving skills as well as administering critical medications may be the difference between life & death. This Paramedic WILL make a difference!! Please pass SB498-SD2 . Thank you!!

Dear Representative Luke:

I am writing to you to support SB 498 to establish a Advanced Life Support Rapid Response Unit in Maalea Maui. The American Heart Association has identified key factors in surviving out of hospital sudden death. A key link in the Chain of Survival is access to rapid Advanced Life Support. Access to rapid ALS is also a key link to survival of many out of hospital emergency conditions such as stroke, internal bleeding, and victims of trauma. Indeed, the "golden hour" is dependent on a rapid initial response to direct a critical trauma patient to the appropriate means of transport to life-saving resources.

As Maui grows, the emergency medical services system is often strained by simultaneous calls and by long response and transport times. It is not unusual for both West Maui ambulance units to be simultaneously engaged in patient care and transport. It is also not unusual for both South Maui ambulance units to be similarly engaged with patient care. Whenever on of these situations occur, an ambulance from another district must be re-positioned to provide a shorter response time to an open district. This leaves emergency response to that unit's primary service area as well as to the vacated service district delayed....a net system loss of response times to both regions.

Further exacerbating this challenge is the new requirement from the State EMSSIP Branch that every ambulance must stay at the hospital until an electronic patient care record is completed except in certain circumstances. Since a serious/critical EPCR involves many fields of data collection besides the documentation of patient care provided, these EPCRs may take an additional 30-60 minutes to complete, sometimes longer depending on the complications of the case and signature collections. Provisions to release an emergency ambulance have been made, providing that a hand written Brief Ambulance Report (BAR) is completed and scanned. This means that emergency ambulance personnel must write out a BAR before they leave the hospital, further delaying the process.

Even if an ambulance is immediately able to respond to the West Side, it would take over 30 minutes to respond to Lahaina and over 40 minutes to reach Napili. And it would take more than 20 minutes to respond to Kihei and well over 30 minutes to respond deep in to Wailea. These response times are not consistent with the AHA's Chain of Survival, nor with documented survival times needed to survive critical medical and traumatic emergencies.

As a former member of the State Emergency Medical Advisory Committee for 8 years and as a member and the Facilitator for the Maui County EMS Advisory Committee for over 30 years, I understand system planning and resource allocation.

I believe that an Advanced Life Support Rapid Response Unit (RRU) placed in Maalaea and that is flexibly deployed to open areas would solve these issues. A RRU can be strategically positioned when ambulances are out of district. An RRU can help coordinated and direct the MEDEVAC helicopter when it is needed. The RRU can help in triage and directing appropriate resources in an multiple casualty incident. And the RRU can help provide Advanced Life Support Coverage (thus strengthening the Chain of Survival) whenever an emergency ambulance is unable to respond in a timely manner for any reason. And since an RRU would be staffed by only one MICT, ALS coverage would be provided in a cost efficient manner.

For these reasons, I urge you to support SB498.
