### S.B. 498, SD2, RELATING TO EMERGENCY MEDICAL SERVICES

Testimony of Loretta J. Fuddy, A.C.S.W., M.P.H. Director of Health

Friday, March 15, 2013, 8:30 am

1 Department's Position: We support this bill provided that its passage does not replace or adversely

2 impact priorities indicated in our Executive Budget and address a revenue stream to carryout intent.

3 Fiscal Implications: Appropriates funds for FY2014 and FY2015 from EMS Special Fund (ESF). The

4 Department is projecting a shortfall in ESF to fund existing ambulance contracts for FY2014 so could

5 not fund these additional services at that time. Due to increasing cigarette taxes and revenues after July

6 1, 2014, increased funding will be available.

7 Purpose and Justification: This measure proposes an advanced life support emergency medical

8 services (EMS) unit stationed at Maalaea in Maui County that can rapidly respond to 911 calls in the

9 surrounding areas. This location is strategically located between the communities of West and South

10 Maui, overall, an area that has grown in population in the past ten years.

11 Emergency response with a non-transporting rapid response EMS unit at Maalaea could

12 significantly reduce the response time to serious and critical medical and trauma cases in Maui County,

13 initiating early treatment and providing additional personnel for multi-victim incidents and for helicopter

14 transports.

15 Thank you for the opportunity to testify on this measure.

Comments: I am writing in support for the HB498 for the SRV EMS unit in Maalaea. The passage of this measure would create a more efficient EMS system on Maui. There have been numerous calls when Westside or Southside units have been on other 911 calls, when patients have had to wait for greater than 30 minutes for an ambulance. As a paramedic in Maui County I see this first hand. Many times we as medics are looked at as the "slow lazy medics who take forever to get there". When we arrive and tell these patients, family members, etc. what the situation is on Maui and the limited number of ambulances and hospitals (one) we have, I frequently have to spend time saying "I know, I know, I don't get it either but we try to get to you as quick as we can". Many of the patients and there families are tourists who are blown away with disbelief that given the distance to our ONLY hospital from Lahaina and Wailea/Makena areas, that there should at least be more resources provided with a faster response time available to make up for that increased distance and lost time. Our medic program is one of the more extensive programs in the country, as EMT's train hard to become paramedics, only to graduate and realize that much more how susceptible to tragedy our current system is. Extensive schooling and all, we have limits in how good we can actually be if we are not provided the resources to do our job. If future projects creating newer communities in Olowalu and Launiopoko are seen through, we must have resources and infrastructure in p lace NOW, and not wait until a situation turns awful where people are asking guestions that have no viable response. Be a part of positive, forward thinking legislation. Thank you for your time and I look forward with great passion to providing the best care for our residents and tourists alike. Comments: Over the past (4) years, increase in resident & visitor populations have resulted in a rise in the number of 9-1-1 calls for Emergency Medical Services in both South & West Maui districts. 2004 was the last year there were any EMS state funds appropriated for upgrades in ground ambulance services. SB #498-SD2 supports a 'special response vehicle' operation that will augment Maui EMS in a more flexible, need-specific way. • It will ADD a FASTER response to the entire Maalaea community where there is no curre nt EMS or fire units stationed. Closest for both responses are from Wailuku + Kihei. • This unit will be able to move into (South or West) Maui districts that may have both of their respective ambulances 'on-assignments' thereby creating a FASTER paramedic response than is currently available coming from another (outside) district. • An additional Paramedic resource will be available for multi-casualty incidents 24/7 including assisting Central Maui area. The Maalaea area has increased its call volume by 64% between 2009 and 2012. Additionally, the WEST Maui Ambulance Districts have received 48% more responses that have come from ambulance units that were 'outside' this district including from Kihei, Wailea, + Central Maui. Any ambulance response from 'out-of-district' results in a LONGER response time. This roving, FIRST Response "special response vehicle" will be able to render Advanced Life Support treatment while awaiting transport. Although transport is important, being able to render IMMEDIATE life-saving skills as well as administering critical medications may be the difference between life & death. This Paramedic WILL make a difference!! Please pass SB498-SD2 . Thank you!!

Regarding SB 498, Relating to Emergency Medical Services

Chair Della Au Belatti, Vice Chair Dee Morikawa, and members of the Committee on Health:

Establishing a Special Response Vehicle (SRV) Paramedic unit for Maalaea, Maui is *literally critical.* Not only is Maalaea itself completely without any paramedic resources, it is located exactly between the busy but under-resourced areas of West, South, and Central Maui. With population and call volume rising substantially, it is becoming alarmingly routine for ambulances to be pulled out of their districts to respond to a far away region of the island. It is untenable for us to provide rapid response and quality care having had no addition of paramedic units for the last nine years. We presented various data to illustrate this problem in support of SB 498. Most of these data ran through the end of 2012.

I offer just one example of how this trend continues: As of this writing, the Kihei ambulance has been pulled out of South Maui to respond specifically to Maalaea, West Maui, and Central Maui 72 times in the 71 days since January 1st, 2013. This same circumstance occurs with other ambulance units multiple times every day, particularly in these busy regions of Maui. Every time this happens, it means an ambulance is forced to abandon its own district, and it means that patients in Maalaea, West Maui, South Maui, and Central Maui may have to wait as long as 45 minutes or more before Advanced Life Support (ALS) care arrives.

With the simple - and remarkably cost effective - addition of a Special Response Vehicle Paramedic unit strategically located in Maui, morbidity and mortality will immediately and markedly improve. While less than half the cost of ambulances in Hawaii, the SRV unit will mark a truly intelligent use of EMS resources. The SRV Paramedic will provide ALS treatment and stabilization, field triage, and will coordinate the appropriate mode of transport when transport is required. In major emergencies, the SRV Paramedic will fulfill a crucial Incident Command role. And in an era of great challenges for community health, the SRV Paramedic unit would be an appropriate venue for expanded scope clinical care and public health outreach. I urge the House Committee on Health to pass SB 498, and I ask that members of the House and Senate actively work to assure its steady progress forward for implementation in the Fall of 2013.

Representative Della Au Belatti, Chair House Committee on Health Re: Senate Bill 498 SD2 Letter in Support

Dear Representative Au Belatti:

I am writing to you to support SB 498 to establish a Advanced Life Support Rapid Response Unit in Maalea Maui. The American Heart Association has identified key factors in surviving out of hospital sudden death. A key link in the Chain of Survival is access to rapid Advanced Life Support. Access to rapid ALS is also a key link to survival of many out of hospital emergency conditions such as stroke, internal bleeding, and victims of trauma. Indeed, the "golden hour" is dependent on a rapid initial response to direct a critical trauma patient to the appropriate means of transport to life-saving resources.

As Maui grows, the emergency medical services system is often strained by simultaneous calls and by long response and transport times. It is not unusual for both West Maui ambulance units to be simultaneously engaged in patient care and transport. It is also not unusual for both South Maui ambulance units to be similarly engaged with patient care. Whenever on of these situations occur, an ambulance from another district must be re-positioned to provide a shorter response time to an open district. This leaves emergency response to that unit's primary service area as well as to the vacated service district delayed....a net system loss of response times to both regions.

Further exacerbating this challenge is the new requirement from the State EMSSIP Branch that every ambulance must stay at the hospital until an electronic patient care record is completed except in certain circumstances. Since a serious/critical EPCR involves many fields of data collection besides the documentation of patient care provided, these EPCRs may take an additional 30-60 minutes to complete, sometimes longer depending on the complications of the case and signature collections. Provisions to release an emergency ambulance have been made, providing that a hand written Brief Ambulance Report (BAR) is completed and scanned. This means that emergency ambulance personnel must write out a BAR before they leave the hospital, further delaying the process.

Even if an ambulance is immediately able to respond to the West Side, it would take over 30 minutes to respond to Lahaina and over 40 minutes to reach Napili. And it would take more than 20 minutes to respond to Kihei and well over 30 minutes to respond deep in to Wailea. These response times are not consistent with the AHA's Chain of Survival, nor with documented survival times needed to survive critical medical and traumatic emergencies. As a former member of the State Emergency Medical Advisory Committee for 8 years and as a member and the Facilitator for the Maui County EMS Advisory Committee for over 30 years, I understand system planning and resource allocation.

I believe that an Advanced Life Support Rapid Response Unit (RRU) placed in Maalaea and that is flexibly deployed to open areas would solve these issues. A RRU can be strategically positioned when ambulances are out of district. An RRU can help coordinated and direct the MEDEVAC helicopter when it is needed. The RRU can help in triage and directing appropriate resources in an multiple casualty incident. And the RRU can help provide Advanced Life Support Coverage (thus strengthening the Chain of Survival) whenever an emergency ambulance is unable to respond in a timely manner for any reason. And since an RRU would be staffed by only one MICT, ALS coverage would be provided in a cost efficient manner.

For these reasons, I urge you to support SB498.
