## **RELATING TO EDUCATION**

Senate Bill No. 49, S.D. 1, amends and repeals various sections of Chapter 302A, HRS, for housekeeping and other purposes. This bill also proposes to exempt from the central service assessment for special funds pursuant to Section 36-27, HRS, the Hawaii 3R's school repair and maintenance fund and the After-School Plus Program special fund.

The department recommends against any exemption from the central services assessment as a matter of financial consistency to administrate and cover the cost of managing the financial accounting required of such an undertaking.

Purpose of Bill: Amends or repeals various provisions of Chapter 302A, Hawaii Revised

Statutes, for housekeeping and other purposes.

## **Department's Position:**

The Department of Education (DOE) **supports** this measure, and appreciates the efforts of the Senate Committee on Education to consider our earlier testimony. We have additional recommendations and proposed minor technical amendments:

1. Section 8: The DOE proposes to **retain** subsections (c) and (d) of Section 302A-605, Hawaii Revised Statutes (HRS), instead of deletion, pertaining to alternative certification for principals and vice principals. The U.S. Department of Education has recently removed "high risk" status for certain areas of the Race To The Top federal competitive grant award. These statutory provisions are necessary for the Hawaii DOE to achieve and maintain the "Assurances" as outlined in the grant.

The DOE supports the **deletions** of the second line of subsection (a) and all of subsection (b) as such deletions are consistent with the Race To The Top alternative certification initiative, and will allow the DOE to establish certification requirements.

- 2. Section 25: The DOE desires to retain Section 302A-1103, instead of deletion. This section clarifies the roles and management responsibilities of school principals.
- 3. Section 13: The bill amends Section 302A-1154, HRS by changing the term "entering" to "attending"; we further request that subsection (b) of the Section 302A-1154, HRS be similarly amended to: "No child shall be admitted to attend any school for the first time in the State unless..." This section pertains to tuberculosis testing.
