In consideration of **SENATE BILL 51** RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

Senate Bill 51 proposes to appropriate \$21,000,000 or so much thereof as may be necessary for Fiscal Year 2013-2014 and the same sum or so much thereof as may be necessary for fiscal year 2014-2015, for the construction of amenities included in the Sand Island ocean recreational park master plan. The bill also appropriates \$8,000,000 for Fiscal Years 2014-2015 for management and administration costs of the State Parks. The Department of Land and Natural Resources (Department) appreciates the intent of the bill but is concerned with the potential impact on the Administration's Biennium Budget.

The Department notes that the Administration's request before the 2013 Legislature includes \$11,000,000 of CIP funding for the development of the Sand Island ocean recreational park for Fiscal Year 2013-2014.
