Senate Bill 524, Senate Draft 1 proposes to establish an agricultural development and food security program. Establishes state planning objectives to increase demand and access to locally grown foods. Establishes state planning objectives to increase production of locally grown foods. The Department of Land and Natural Resources ("Department") supports this measure but recommends that the bill be amended to include three critical elements.

- 1) Designate someone within the Department of Agriculture with direct responsibility to implement a food resiliency program. The position needs to be fully funded with a fully funded support staff to coordinate and implement the plans.
- 2) The program needs to outline specific tasks to be accomplished.
- 3) Any program and/or initiative for food resiliency must be able to measure progress through appropriate, comprehensible, specific and practical metrics, which both the farm community and the public can easily understand.

The Department strongly supports measures that will aggressively advance Hawaii's goal of food self-sufficiency.

The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers and a utility company. LURF's mission is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of SB 524, SD1** and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands (IAL) in Hawaii. The bill conveys the need for collaboration amongst diverse sectors of the community business, government, and agricultural stakeholders - and the importance for them to work together cooperatively to improve the economic viability of the State's agricultural industry.

SB 524, **SD1**. This bill authorizes the creation of an agricultural development and food security program within the Department of Agriculture ("DOA"); establishes state planning objectives to increase demand for, production of, and access to locally grown foods; and makes appropriations accordingly.

LURF's Position. SB 524, SD1, which is supported by the DOA, the Hawaii Farm Bureau and other recognized agricultural stakeholders, duly proposes to implement the recommendations of the *Increased Food Security and Food Self-Sufficiency Strategy*, the report prepared in October 2012 by the State Office of Planning in cooperation with the DOA, to increase the amount of locally grown food consumed by Hawaii residents..

This bill is also consistent with the underlying intent and objectives of the IAL laws (Hawaii Revised Statutes [HRS], Sections 205-41 to 52), which were enacted to fulfill the mandate in Article XI, Section 3 of the Hawaii State Constitution, "to conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the

availability of agriculturally suitable lands." As noted in HRS Section 205-41, the intent of Act 183 (2005) was to develop agricultural incentive programs to promote agricultural viability, sustained growth of the agricultural industry, and the long-term use and protection of important agricultural lands for agricultural use.

Passage of the long-awaited IAL legislation would be pointless without implementation of these inducements which require the cooperation and support of agricultural, business and educational organizations, as well as government agencies, which this bill is intended to cultivate and promote.

By recognizing the significance of, and need to advance the interrelationships between private and public sectors to develop and improve the local agriculture industry, and establishing a program to identify the objectives and address the needs of the industry, this bill significantly helps to promote economically viable agriculture and food self-sufficiency in Hawaii. As such, LURF is in **strong support of SB 524, SD1**.
