I speak on behalf of myself as a private citizen not on behalf of the University of Hawaii, where I am a professor in the John A. Burns School of Medicine's Department of Public Health Sciences.

As a public health physician who has specialized in the treatment and control of sexually transmitted diseases for close to three decades, I fully support this bill to allow Hawaii to join 32 other states, including California, which allow for expedited partner therapy (EPT).\* Please note, that this important strategy is fully supported and recommended by both the US Centers for Disease Control and Prevention (CDC) and the American Congress of Obstetricians and Gynecologists (ACOG). I am also fully supportive of the proposed revisions to the bill that are being proposed by the Hawaii Section of ACOG. Dr. Lori Kamemoto and her colleagues in the Hawaii Section of ACOG have worked closely with the Hawaii State Department of Health in consultation with the CDC to develop the amendments which will further strengthen this needed legislation. EPT is an evidence based approach which has been shown to decrease the spread of sexually transmitted infections (STIs) and to decrease the risk of reinfection of patients who have been treated for STIs.

I am submitting testimony in strong support of SB 655 with amendments as recommended by the American Congress of Obstetricians and Gynecologists (ACOG), Hawaii Section.

Many patients with Chlamydia have partners who, for one reason or another, don't get treatment on their own. This often results in re-infection for the primary client. Each subsequent Chlamydia infection increases a woman's risk for pelvic inflammatory disease and potential infertility. Expedited Partner Therapy (EPT) has been recommended by the CDC since 2006, and a majority of states have provided for EPT with remarkable success at the reduction of Chlamydia rates. Here in Hawaii we have not had that legal protection, although we have consistently remained among the top ten states in the country for the incidence of Chlamydia. Our rates increased by 10% in the first half of 2012 alone. The CDC now reports that EPT is the best method for treatment of Chlamydia, yet we are not allowed to do it here in Hawaii. This has proved embarrassing for me personally when attending conferences on the mainland and trying to explain to other professionals about our efforts to control the spread of Chlamydia while not using the most effective method of treatment delivery.

I strongly support this bill with amendments as per Hawaii ACOG testimony. This bill will benefit our patients as well as public health by decreasing the burden of sexually transmitted infections in Hawaii.

I have personally witnessed four women with ectopic pregnancies in the past 2 years each having had a past history of a chlamydia infection in thier younger years. Infection with chlamydia can have lifelong implications in future fertility including life threatening complications. We as nurse midwives strive to provide health care that contributes to positive outcomes and the preservation of childbearing rights of all women. Without the ability to treat partners through the PPT method we are missing valuable opportunities to safe guard our patients from reinfection.

I strongly support this bill with amendments as per Hawaii ACOG testimony. This bill will benefit our patients as well as public health by decreasing the burden of sexually transmitted infections in Hawaii.
