SENATE BILL NO. 681 RELATING TO FOOD SECURITY

Chairpersons Nishihara and Espero, and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill No. 681. The purpose of this bill is to establish a temporary food security task force in the Department of Agriculture to develop an emergency food plan that addresses certain food security issues. The Department supports the intent of the bill but believes the National Disaster Preparedness Training Center at the University of Hawaii may be better suited to lead this task force.

By some estimates, Hawaii imports over 85% of its food which can be disastrous should a natural disaster of some kind disrupt imports in to the island. The Department agrees that this is a concern that should be addressed. However, while the Department does have expertise regarding agriculture, we lack the experience and network needed to lead a discussion on the proper security measures and protocols that should be undertaken in the case of an emergency or catastrophic event. The National Disaster Preparedness Training Center at the University of Hawaii incorporates a Whole Community Concept in developing and delivering training and education in areas of disaster preparedness, response, and recovery. Their experience with governmental,

private, tribal, and non-profit entities would make them uniquely suited to lead a task force of the type described in this bill.

Comments: I would like to voice my concerns on SB 681 to establish a food security task force to develop an emergency food plan for the State that addresses certain food security issues resulting from an emergency, catastrophic event, or quarantine. Food security is a critical issue for Hawaii, and is a clear example of the left hand not knowing what the right hand is doing. With estimates from 85% to 90% of Hawaii's food currently being imported, it is clear we are on the wrong path and need to take bold measures to create a sustainable community. That would include preventing some of the best agricultural land in the state from being converted to urban development, namely Hoopili, not to mention other development plans not in our food-security best interests. In previous conversions I've had with Senator Espero, he recommended partnering with Monsanto as the solution to our food security problems. If that is the true intent of this bill, I would warn that this is not a solution. but would only contribute to the problem. We need to be supporting real farmers who are growing real food, not GMO crops that have lower yields and require much higher pesticide use. Please don't take a wonderful idea such as reducing our food security vulnerability and destroying it with non-solutions like Monsanto.
