Comments: Cannabis has been proven to be effective in the treatment of pain and has helped patients reduce their use of more dangerous prescription drugs. Cannabis is a safe medication that is relatively non-addicting and has no known fatalities. Many scientific studies now prove that cannabis is also a very effective pain medication, especially for the most difficult to treat chronic pains such as nerve pain. Hawai'i Medical Association (HMA) passed a resolution recommending that cannabis be rescheduled as a Schedule III controlled substance (same as Vicodin) that could be routinely prescribed by physicians.
