Comments: The current bill includes this language stating that the fingerprinting process "May" be waived at the chief of police's discretion. This language needs to be changed, "Shall be waived" is what it ought say. Fingerprints do not change. It is a waste of money and especially manpower at the already overtaxed HPD firearms department to require individuals who already have prints on file to pay the fee and have prints taken a second time. In addition the bill does not explicitly provide for expansion of registration and permitting locations. The sole Oahu location at HPD HQ in Honolulu is far beyond it's capability to handle the demand, and there is little reason permits and registrations cannot be carried out in other police stations throughout the state. Current waiting times on not only acquiring permits, but registering firearms, both in and from out of state take 5 hours or more. People are essentially being forced to camp out in front of the station overnight with their firearms, simply so they get the opportunity to register their firearms, to avoid being in violation of the law. This is not only unnecessary, but it also puts these individuals at risk as they are forced to wait at 4:30 in the morning for a chance at registering their firearms.

Comments: Individuals who bring firearms into Hawaii from another state, even on a temporary basis, are already required to register their firearms within 72 hours. SB 69 now adds a fingerprinting, photographing, AND a background check requirement on the gun owner in addition to the already burdensome registration requirement on such legally possessed firearms. These requirements are so onerous that if one acquired an antique firearm or an unusable or unserviceable firearm, they would still have to undergo the entire background check, registration and fingerprinting process. In summary, what is known is that SB 69 presents no viable solutions that would make improvements to Hawaii, but instead attacks law-abiding citizens who are choosing to exercise the right to own a firearm. Please do not pass this bill, and please stop the attacks on law abiding gun owners !!!

I have received training on weapons ranging from the M9 Pistol, M16A2 Rifle, M4A1 Rifle, M249 Machine Gun, M240B Machine Gun, M2 50 Cal. Machine Gun, MK19 40mm Machine Gun, AT4 Rocket launcher, 155mm Howitzer, and Explosives that I have had to use over the course of my career. My wife as well has been trained on various weapons. Not to mention that we have both been investigated in order to obtain our concealed carry license. On a daily basis our rights are being infringed upon because we are not allowed by the State of Hawaii to carry our weapons for the sole purpose of protecting our family. We oppose SB 69 due to the fact that under current law the State of Hawaii already restricts us from practicing our constitutional rights guaranteed to us not only by the Constitution of the United States of America but the State of Hawaii's constitution as well. Vote NO on SB69. Hawaii's gun laws are already unconstitutional and ludicrous enough. Do committee members really understand what is required for a law-abiding citizen to purchase a firearm? The process is as follows:

- 1. Take a two-day gun safety class to receive certification.
- 2. Take certificate to HPD and file paperwork to receive license to buy a gun.
- 3. Return to HPD in two weeks to pick up license.
- 4. Go to gun store to select gun. Fill out paperwork and pay for gun, but leave gun at store.
- 5. Return to HPD to file paperwork to purchase gun.
- 6. Return to HPD in two weeks to pick up permit to purchase gun.
- 7. Take permit to gun store to take possession of gun.
- 8. Take permit, gun, and gun-store paperwork to HPD to register gun.
- 9. Take gun home, but do not bother to go to the one and only public range on Oahu. It is only open three hours per day on Wednesday-Friday and six hours a day on weekends. It is so crowded that people are lining up at about 3:00 am to get a spot.

Note each visit to HPD requires citizens stand in line 2-3 hours to obtain license, permit, and registration. A criminal, on the other hand, merely buys a gun on the black market, no permits, license, or training is required.

If you really want to make citizens safer, restore their right to protect themselves:

- 1. Eliminate the need to register firearms. Criminals do not register their firearms and in the 70+ years that Hawaii has required registration, not one crime has been solved using this data collected from law-abiding citizens.
- 2. Allow the gun stores to perform background checks ala Arizona. Eliminating registration and transferring background checks to the private sector will save enough money to put more police on the streets. We can stop monitoring the activities of law-abiding citizens and focus on the criminals; criminals, out-of- state or otherwise, will not bring their firearms in for registration.
- 3. Eliminate the need to obtain a concealed carry permit. If you can legally buy a firearm, you can carry it. What use is a firearm for self-defense, if you must leave it in a locked safe at home? In practice, HPD does not even grant carry permits to anyone other than LE personnel. The real law-breaker is the government that denies citizens their constitutionally-recognized right to bear arms.
