**TESTIMONY ON SENATE BILL NO. 8, S.D. 1, RELATING TO VETERINARY
MEDICINE.**

TO THE HONORABLE ANGUS L.K. MCKELVEY, CHAIR,
AND MEMBERS OF THE COMMITTEE:

My name is John Kaya, D.V.M. and I am the Chairperson of the Board of Veterinary Examiners ("Board"). Thank you for the opportunity to present testimony on Senate Bill No. 8, S.D. 1, Relating to Veterinary Medicine.

The purpose of this bill is to prohibit the owner of a pet animal and the owner's employee from performing any surgical procedure, including but not limited to surgical birth, ear cropping, tail docking, dewclaw removal, and debarking, without being a licensed veterinarian. Also, any person convicted of violating section 471-2 and who, in the course of that violation, intentionally or knowingly performs any surgical procedure shall be guilty of a class C felony.

Unfortunately, the Board meets four (4) times a year and has not yet held a meeting at which the language or substance of this bill has been available. Therefore, there is no official position on this measure at this time. The Board will be discussing this bill at its next scheduled meeting on Wednesday, April 17, 2013.

On behalf of our members and supporters of The Humane Society of the United States in Hawaii, we thank you for the opportunity to speak in strong support of SB8 SD1; Relating to Veterinary Medicine.

This important measure would prohibit unlicensed veterinarians and non-veterinarians from performing cruel surgical procedures on pet animals, and set forth appropriate criminal penalties. This bill is necessary as our current animal cruelty law exempts “cropping and docking as customarily practiced” but does not require that these procedures be performed by a professional licensed veterinarian. This law only applies to pets, not farm animals.

Ear cropping, tail docking, declawing, debarking and any other surgical procedure is extremely painful to an animal if proper pre and post-operative care and anesthetic are not administered. Non-veterinarians performing these procedures often forcefully restrain and bind the dogs with duct tape, then use razor blades, box-cutters or simple scissors to cut the dogs’ ears and/or tail.

Ear-cropping by non-veterinarians is also a common procedure performed on dogs prepared for and used in illegal dogfighting to prevent bleeding from torn and ripped ears, which may compromise the dogs’ vision and ability during a fight.

Unfortunately, we have seen many cases where individuals (non-veterinarians) have attempted to perform such procedures on pets, resulting in extreme suffering. In addition, if not performed by a professional veterinarian, these procedures can result in serious infection, blood loss, shock and even the death of the pet.

We respectfully urge your support of this measure, which is also supported by the Hawaii Veterinary Medical Association, local statewide humane societies and many others.

The Hawaiian Humane Society strongly supports the passage of Senate Bill 8, Senate Draft 1 as it prohibits laypersons from performing certain surgical procedures without being licensed as a veterinarian pursuant to section 471-2 Hawaii Revised Statutes.

Surgical procedures should only be performed by licensed veterinarians as they can result in negative physical consequences and can be extremely painful thereby resulting in distress. Surgical births, or otherwise known as cesarean births, tail docking, ear cropping, and debarking are some examples of these procedures where, if performed improperly by a layperson, could cause serious pain and suffering to the animal. Also, various procedures require critical post-surgery care in order to ensure that the wounded area is not infected or otherwise compromised. As with all surgical procedures, there are inherent risks of anesthesia, blood loss, and infection to the animal in addition to the emotional distress.

In order to ensure that all animals are treated humanely in all aspects of their lives, it is incumbent for all surgical procedures to be performed by the licensed veterinarians as deemed qualified by statute.

Thank you for the opportunity to testify in support of SB 8, SD 1, relating to veterinary medicine. On behalf of the Hawaiian Humane Society, I ask for your support in passing this measure.

Dear Chair McKelvey, Vice Chair Kawakami, and Members of the Committee on Consumer Protection and Commerce,

The Senate Committees on Commerce and Consumer Protection, and Judiciary and Labor have found that “surgical procedures, including surgical birth, ear cropping, tail docking, dewclaw removal, and debarking, are extremely painful to a pet animal if performed improperly by someone other than a licensed veterinarian. Serious infection, shock, and even death of a pet animal can result when these procedures are performed by non-veterinarians.” These Committees have further found that “pet animals that undergo these surgical procedures require proper pre- and post-operative care and anesthesia to reduce complications, blood loss, and distress. This measure therefore promotes the humane treatment of pet animals by ensuring that pet animals undergoing surgical procedures will do so under the care of an appropriately licensed veterinarian.”

I support the passage of SB8 creating felony crimes for non-licensed veterinarians who perform surgical procedures on pet animals. Ultimately, the pet animals who suffer at the hands of non-licensed veterinarians may end up in front of a veterinarian who has to clean up the mess that’s been created, or they will suffer silently and needlessly, sometimes even dying at the hands of these non-licensed perpetrators. While the cost of veterinary care can be expensive and budgets are tight these days, that’s no excuse to continue to allow the needless suffering of animals. People must take responsibility for their pets. Eliminating the option of taking animals to non-licensed veterinarians can go a long way in curbing some animal cruelty.

According to a report compiled by the Animal Legal Defense Fund (www.aldf.org) that assessed the strength of each jurisdiction’s animal protection laws, Hawaii ranked #43 out of the 50 states for 2012. We were recognized as one of seven states who for the first time enacted a felony penalty for cases involving extreme animal cruelty. The report ranks states (and the District of Columbia and U.S. territories) based on their cumulative scores to 42 study questions covering 15 distinct animal protection laws categories. I believe that the passage of this measure is one step toward rising out of the bottom tier when it comes to animal protection laws.

I strongly believe that the passage of this bill is a necessary step to take in order to improve the lives of pet animals in Hawaii, and I urge you to support the passage of SB8 relating to veterinary medicine.

I own a Boxer dog, a breed that customarily has a cropped tail and cropped ears. And, Pit Bull types are hugely popular here, which is another breed with ears that are cropped. I have personally seen the disastrous effects of a poor crop job on tails and ears. This delicate surgery must be done properly or animals suffer. It's that simple.

I hope you get some testimony from Hawaii's veterinarian community who no doubt have firsthand experience fixing these botched, painful backyard surgeries from suffering pets. Many of these veterinarians may tell you that they oppose docking and cropping all together, as this is the position of the American Medical Veterinarian Association. However, these surgeries are extremely popular in Hawaii. **The sad truth is that like abortion, this practice if outlawed would continue to go on without anesthesia, without pain medicine and without follow-up care.**

And currently, that's shamefully legal.

We wouldn't allow average citizens to perform surgeries on people. What makes animals ok?

These creatures deserve our voice and our protection and our advocacy.

Comments: I support most of this bill with the exception of dew claw removal and tail docking. I support the amendment asking that non-vets be allowed to do dew claw removal and tail docking if done before 5 days of age. These 2 procedures need to be separated from the other surgical procedures listed in this bill for the following reasons: 1. This bill assumes that every person who wants their litter of puppies to have their tails docked and dew claws removed has reasonable access to a veterinarian. The islands of Molokai & Lanai have no resident vets. There is a small window of no more than 5 days to have these procedures done. After 5 days, the nerve endings and cartilage grows in. 2. New born pups are born underdeveloped. When a veterinarian does these procedures in their offices, anesthesia and a surgical suite are not used. There is little if any blood. 3. Breeders who have done these procedures do so for various reasons to include: a. They do not want to expose newborns to highly contagious and life threatening diseases like parvo virus. b. They do not want to subject puppies to a long car ride to get this procedure done. Even on Oahu, accessibility could be an issue since only about 50% of the vets do these 2 procedures. c. Veterinarians may not be knowledgeable in knowing how to properly do tail dockings for each of the different breeds.
