SB 963 – RELATING TO THE UNIVERSITY OF HAWAII

Chair Taniguchi, Vice Chair Kahele and Members of the Committee:

The University of Hawai'i respectfully opposes the proposed repeal of the University of Hawai'i tuition and fees special fund and conforming amendments.

Presently, section 304A-2153, HRS, allows the University of Hawai'i to retain all revenues from tuition and fees charged for courses of instruction, which has become a core source of funding for the academic programs of the University of Hawai'i. Without this user-fee revenue, the University's funding would become reliant upon the limited discretionary revenues from the State of Hawaii's general fund, which would not support long-term stability for our academic programs. This long-term stability is important for two reasons.

First, the current methodology of adopting multi-year tuition and fee schedules provides a more predictable revenue stream compared to the annual variances in the general fund. This funding stability permits the University of Hawai'i to more effectively engage in long-term academic planning in support of achieving our multi-year performance goals. Should we lose the stability of the tuition and fees revenue stream, our operations would proceed on a more ad hoc basis subject to the availability of government support.

Second, tuition and fee revenues allow the University of Hawai'i to more quickly respond to such factors as increasing enrollments and rising utility costs. Our ability to reallocate tuition and fee revenues and leverage our two primary funding sources would not be possible with sole reliance on general fund revenues.

RELATING TO THE UNIVERSITY OF HAWAII

Senate Bill No. 963 proposes to repeal the University of Hawaii (UH) Tuition and Fees Special Fund, lapses the special fund balances to the general fund, and appropriates an unspecified amount of general funds to UH for FY 14 and FY 15.

While the Department of Budget and Finance does not take any position on the policy issue of appropriate funding sources for UH, we offer the following comment. With the limited general funds resources to support the State's various departments and programs, general funds to support higher education could be constrained in the future dependent upon revenues and statewide priorities. Additionally, the ability to meet fluctuations in resource requirements due to projected student enrollments and proposed program expansions may be limited due to limited resource constraints.

TESTIMONY SUBMITTED IN OPPOSITION TO SENATE BILL 963

Aloha Chair Taniguchi, Vice Chair Kahele and Representatives of the State Senate Committee on Higher Education:

My name is Bonnyjean Manini. I am a proud product of this 'āina and Hawai'i's public school system. I grew up on the island of Kaua'i and am now a faculty member at the University of Hawai'i at Mānoa. Currently I serve as the elected Chair of the 2012-2013 Mānoa Faculty Senate Executive Committee. This also makes me the Chair of the Mānoa Faculty Senate.

On Monday, February 4th, the Mānoa Faculty Senate Executive Committee voted in opposition to SB963, introduced by Chair Taniguchi, which seeks to lapse all University of Hawai'i tuition and fees to the state general fund. My colleagues and I ask this committee to oppose this bill.

The remainder of this statement is my own personal testimony. I do not speak on behalf of the University.

The *blunder* of Summer and Fall 2012 keeps playing over and over.... now it seems to be threatening the University through numerous pieces of legislation like the one before us today.

I oppose SB963 because it has the potential to negatively impact our students. This bill allows for the taking of money entrusted to the University of Hawai'i, for an intended purpose, that of tuition and/or a specific fee. With that taking there is no guarantee that the state legislature will ever appropriate these funds back to be used to educate our students, its intended purpose.

Public higher education is a priority in civilized societies because it contributes to the greater good. The investment of public funds in public higher education is a necessity if we hope to continue educating and preparing our young people to contribute to our society in an active and engaged manner. As you know, public funds in this state include a combination of general funds appropriated by the state legislature and special or revenue funds the University earns based on goods and services we employees work to provide. The University of Hawai'i at Mānoa needs all the funds that have historically been appropriated through general funds as well as our tuition and fees in order to effectively serve our students.

Tuition and fees paid by students towards their education at the University of Hawai'i at Mānoa is used to enhance the educational environment beyond the general fund appropriation by allowing the campus to invest our student's hard earned money into such things as additional scholarship funds, improving classrooms, improving

technology, improving campus safety, paying increasing utility bills, and improving the overall educational experience for the students.

Let's be transparent and say that the taking of the University's tuition and fees also hurts me, a faculty member. At this time, tuition and fees are also covering some of the cost of faculty salaries since the current general fund appropriations from the legislature does not cover the full cost of our salaries. This is despite the fact that as faculty members we are state employees with a legally binding collective bargaining agreement. As a public employee that works long hours both at the office and at home, often using my own salary to buy resources for my work with students, this makes no sense. On average, I choose to work 14-hour days, 52 weeks a year because I take pride in my work. I do not receive or expect to receive overtime for my long hours. I love my work and give of my personal time freely. Knowing that my state legislators are not willing to cover the cost of my salary with general funds concerns me. Knowing that my campus makes up the difference through tuition dollars that are now being threatened by legislators through SB963 is alarming.

The irony of the *blunder* this past summer as compared to what is happening here today is that the *blunder* was a mistake made by a series of human errors that was caught after the fact. SB963 is a mistake that the members of this committee has the ability to stop before it happens.
