#### SENATE BIL 993, SD2, HD2 RELATING TO AGRICULTURAL LOANS

Chairperson Luke and Members of the Committee:

Thank you for the opportunity to comment on SB993, SD2, HD2. The Department strongly supports this bill.

This bill will create a low interest loan program to assist the livestock and poultry industry renovate their existing structures or construct new infrastructure to ensure they are bio-secure and meet new Federal requirements. The improved bio-secure infrastructures will result in a safer food supply and prevent the spread of livestock and zoonotic diseases amongst wild animals, the herd and humans while helping to ensure that fresh eggs, beef and pork remain available to Hawaii's citizens.

The bill also enhances the new farmer loan program by including farm innovation loans to encourage development of new crops and use of technology and new growing techniques to keep Hawaii's farmers viable with growing worldwide competition. The bill also broadens the program to include graduates from farm trainee programs and reduces the equity contribution required in order to encourage young entrepreneurs to enter the agricultural field. The lowered contribution amount of 5% will make it easier for these recent graduates to qualify for an agricultural loan and start their own operations.

The bill broadens the agricultural loan program to assist segments of the farming community by providing access to capital at favorable interest rates and terms.

Organized since 1948, the HFBF is comprised of 1,950 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

HFBF respectfully requests your support of SB 993, SD2, HD1, which expands the Department of Agriculture's Agricultural Loan Program by adding farm innovation and biosecurity loans and expanding the definition of a new farmer.

The cost of establishing new agricultural operations in Hawaii is very difficult if not impossible. Operating capital is not easy to obtain with the traditional methods of financing.
