Dear Chairman Taniguchi, Vice Chairman Kahele, and Members of the Senate Higher Education Committee:

My name is Stanley H Roehrig. I am a local boy. I was born and raised in Manoa and moved with my young wife to Hilo to practice law in 1966. We raised our family in Hilo and we have been here ever since. I met Keahi Warfield, the architect for the RISE After School Program, in about 2002 on the campus of UH Hilo. We have been friends ever since. My wife and I are dedicated to seeing the proper development of Keahi's RISE Program as a permanent part of the University of Hawaii at Hilo, 'Imiloa Outreach Program.

For many years, those of who live in the Keaukaha area have recognized the importance of a first rate after school program for youngsters between ages 8 and 18. We want them to have a chance to get into Hawaii Community College and into the various Baccalaureate Programs at UH Hilo. This group needs special attention after school if we are going to achieve that. Many of them don't get a warm dinner at home. Many of them live with their grandparents. Keahi is a born leader down here in Keaukaha. We believe that he and his team will be successful in their after school program efforts if we properly support them during the early years until it is up and running.

UH Hilo has no extra funds for a new program, consequently, the senate resolution will need to be amended to reflect that this new RISE Program will merely be an extension of the existing 'Imiloa Outreach Program and will have no impact on the current UH Hilo budget. The Budget Proviso draft, Exhibit "A", was drafted by UH Hilo Chancellor Straney's Executive Assistant Gail Makuakane-Lundin, who is currently in Washington D.C. The proviso reflects in part that, "the RISE Program will be coordinated by the UH Hilo 'Imiloa Astronomy Education Center administration as an outreach to the Keaukaha/Panaewa area, designed to provide early preparation for entry into the Hawaii Community College and the Baccalaureate Programs at the University of Hawaii, Hilo. Funding for this program shall not replace or adversely impact existing Hawaii Community College or UH Hilo funded programs or priorities".

We agree to work around these budget constraints. Ka'iu Kimura and Keahi Warfield have been having weekly discussions on curriculum development. The curriculum development and infrastructure planning will continue until our first group of RISE participants starts the program in September of 2013 at the Doc Hill premises, here in Keaukaha.

Thank you for your consideration of this important matter.
