Chair Ige, Vice Chair Kidani and Members of the Committees:

Hawaii P-20 strongly supports SCR 96 which commends the creation of the Jump Start Program, encourages expansion, and requests continued support by the Hawaii DOE and UH. There is compelling research across the nation on the positive impact of "early college" programs to engage students in learning, to increase high school graduation rates, and to increase collegegoing rates. A very recent study in 2013 cited by *The Teachers College Record* at Columbia University states that students in early college programs (such as Jump Start) had better attendance, lower suspensions, and high levels of engagement in learning.

The level of support by the Hawaii DOE high schools and the participating UH community colleges, as well as the support by the legislature and the Office of Senator Jill Tokuda, have been essential to the success of the students in the cohorts thus far.

Continuation and Expansion of the "Jump Start" Dual Enrollment Program

Aloha, Chair Ige, Vice Chair Kadani, and members,

My name is Frank Haas, Dean for the Career and Technical Education programs at Kapi'olani Community College and I am testifying in support of Senate Concurrent Resolution 96.

Kapi'olani Community College has been a part of the Jump Start pilot project since its inception. The pilot project has been very successful in developing the procedures and guidelines necessary to enable Jump Start to move from an experiment to an important part of an integrated Department of Education/Community College Career and Technical Education program. We have successfully enrolled two cohorts of high school students into our CTE programs and are about to enroll a third cohort in the fall.

Jump Start provides an opportunity for students who are focused on career and technical education to literally "jump start" their CTE education. Often these students do not have access to the CTE programs that interest them at their high schools. Furthermore, enrolling in a Community College CTE program in their senior year keeps them motivated by engaging them in subject matters that spark their interest and enthusiasm. In addition to these benefits, the Jump Start program provides students with the opportunity to accelerate their academic career and, not incidentally, to save money.

The Jump Start pilot project has been a successful example of partnership between the University of Hawai'i system, the Department of Education, and individual Community Colleges and High Schools.

We see Jump Start as an excellent program which can expand the impact of Career and Technical Education training in Hawai'i.
