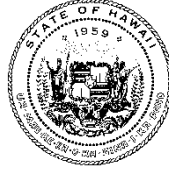

I am Eva Laird Smith, executive director of the State Foundation on Culture and the Arts. I am pleased to support Senate Concurrent Resolution 29 / Senate Resolution 10, provided passage of these resolutions do not replace or adversely impact priorities indicated in the Executive Budget.

The State Foundation on Culture and the Arts situated in the historic No.1 Capitol District Building just across the State Capitol, has been involved in encouraging the growth of cultural tourism since the decision was made to move our agency to its current location in the heart of the Capitol District. We opened the Hawai'i State Art Museum in 2002, a café and amenities a few years later, and our interest has always been to share Hawaii's history and culture with our residents and visitors through a visitor information program.

Today, our HiSAM volunteers staff the information desk on the ground floor of our building, providing information and a warm welcome to all visitors. An informational kiosk within the historic district would greatly facilitate recreational visits to the downtown area,

and serve to highlight the various cultural differences along a cultural hub.

We are long overdue for attractive signage and directional displays of not only historic buildings and the State Capitol, but also the downtown business district where First Friday programs, restaurants, private art galleries, and retail shops continue to grow. Our agency stands ready to facilitate the development of an informational kiosk, with support from DAGS and the Hawaii Tourism Authority.

The Hawai'i Tourism Authority (HTA) opposes S.C.R. 29 and S.R. 10, which urge the Department of Accounting and General Services and the Hawaii Tourism Authority to build and operate an information kiosk in Honolulu's historic district.

HTA does not actively build/develop or operate informational kiosks. The HTA works with public and private entities and nonprofit organizations to develop and rejuvenate various elements of the tourism product, but does not get involved in the building and operating of any visitor products.

Any of the organizations mentioned in the resolutions may apply through HTA's Product Enrichment Program for the development and operation of any program to promote and support their historic programs.

For these reasons we oppose S.C.R. 29 and S.R. 10 and request that they be held.
