# Crossover . . .

The House of Representatives has passed a number of bills that address concerns about the economy, school furloughs and the environment. These bills now move to the Senate for further consideration.

#### Economy

The House has been working on measures that would enhance revenue to address a projected \$1.8 billion shortfall. This would be accomplished by increased taxes on liquor (HB 2850 HD1), insurance premiums (HB 2851 HD1) and

financial institutions (HB 2872 HD1), limiting tax credits and temporarily suspending the exemption of use, GET and Public Service Company taxes on certain individuals (HB 2877 HD1). quarantine inspection, Child Protective Services, Adult Protective Services and Public Welfare Eligibility Workers.

The budget also includes numerous capital improvement projects for the Big Island including \$31 million for the College of Hawaiian Language at the University of Hawaii at Hilo.

HB 2169 Unemployment Insurance—assists employers and employees by lowering the unemployment insurance (UI) contribution rates for employers and adjusting the benefit amounts paid to employees

from the UI trust fund.

#### HB 2736 Local Hiring—

requires 80 percent of workers on public works and construction contracts to be state residents. This will greatly benefit our local construction industry that has been badly hurt

by the economic downturn.

#### HB 2486 Educational

**Hours**—sets a minimum number of instructional hours within the school year. Concerned parents felt that instructional

#### Health

**HB 2394 Vog Related Respiratory Equipment**—Provides a refundable tax credit for the purchase of respiratory equipment to protect

against the effects of vog.

HB 2989 Hospital Disclosure requires hospitals to report hospitalacquired infection rates and the Department of Health to make this information public, while pro-

public, while protecting patient privacy.

HB 2657 Sub-

bility for school officials to increase the amount of instructional time without radically altering the school calendar.

### HB 2376/2377 Appointed School

**Board**—allows the governor to appoint the

State Board of Education. This will create greater accountability for the governor in education.

#### HB 985 Fiscal

**Accountability**— would create a procedure for the principal to involve the greater school community in resource allocation before it is approved by the school community councils.

#### Environment

#### HB 2427 Solid Waste Re-

**ports**—changes the interval between revisions of the county HB 2421 Food and Energy Security—appropriates funds to promote economic development for local food and energy businesses to ensure Hawaii is energy and food self-sufficient to the maximum extent feasible.

**HB 2643 Clean Energy Bonds** creates a loan program for renewable energy system and energy efficiency improvements on residential and commercial properties. This will allow people to be able to afford energy efficiencies. stance Abuse Wellness Center-

requires the Department of Public Safety to plan a model wellness center preferably at the former Kulani Prison.
