CHARTER OF INCORPORATION

TO ALL WHOM THESE PRESENTS SHALL COME:

I, WAYNE MINAMI, Director of Regulatory Agencies,
State of Hawaii, send greetings:

WHEREAS, Betty Minobe, Karen Hosaka, and Kellet Min,
each and everyone of whom is a resident of the State of Hawaii,
have petitioned to me as such Director to grant to them and
their associates a Charter of Incorporation under the name of
"FARRINGTON ALUMNI AND COMMUNITY FOUNDATION" for the following
purposes: To maintain, promote, and foster the development of
Farrington High School; to provide a means of communication to
and for alumni; and to develop and maintain fellowship amongst
the alumni, faculty, administration, students and the Farrington
Community.

NOW, THEREFORE, KNOW YE that I; the said Wayne Minami
as such Director of the aforesaid, by and with the consent of the
Governor of said State, and in the exercise and execution of every
power and authority in anywise enabling me in this behalf, hereby
constitute Betty Minobe, Karen Hosaka, and Kellet Min and their
associates a charitable corporation under the laws of the State
of Hawaii.

I.

Name

The name of the corporation shall be the "FARRINGTON ALUMNI AND COMMUNITY FOUNDATION".

II.

Location

The address of the corporation shall be 1564 North King Street, Honolulu, Hawaii 96817. The Board of Directors may select another location and address as the affairs of the corporation may require.

III.

Purposes

The purposes of the corporation are: to maintain, promote, and foster the development of Farrington High School; to provide a means of communication to and for alumni; to develop and maintain fellowship amongst the alumni, faculty, administration and students; to grant scholarships, loans, and other assistance to young students of promise; to encourage and provide funds for innovative school projects; to provide funds encouraging student and teacher accomplishments such as supplementing travel allowances, recognition dinners, special field trips, and workshops; to promote the general welfare of Farrington High School and the Farrington Community.

IV.

Duration

The duration of the corporation shall be in perpetuity.

V.

Membership

The charter members of the corporation shall consist of the persons signing this petition and contributing not less than \$10 prior to Dec. 31, 1976.

Membership to the foundation shall be open to the alumni and the Farrington community.

For the purposes of this charter, alumni shall mean students who attended Farrington, graduates of Farrington, and present and past staff members. Voting members shall consist of alumni who have contributed in accordance with the provisions of the bylaws.

Membership without vote shall be open to the Farrington community such as to community leaders and business enterprises upon their contributions of not less than \$10 to the corporation.

Any member may be expelled from the corporation for cause upon two-thirds vote of the Board of Directors.

VI.

Bylaws

The bylaws shall be adopted and approved by majority of the charter members and by the Board of Directors and thereafter they may be amended from time to time by majority vote of the members of the corporation present and voting at any meeting, provided that notice of the proposed amendment shall be given to the

members in accordance with the bylaws.

VII.

Officers

The officers shall consist of a President, a First Vice President, a Second Vice President, a Recording Secretary, a Corresponding Secretary and a Treasurer.

VIII.

Initial Officers and Directors

There shall be a Board of Directors consisting of not less than six members. The following persons and such others who may be elected this year, shall be the initial officers and directors and shall hold office for the first year or until their successors are duly elected pursuant to the by-laws of the corporation:

IX.

Powers

The corporation shall have only such powers as provided for by law necessary to accomplish its stated purposes.

X.

Non Profit and Succession

The corporation is organized for educational, charitable and scientific purposes only and is not organized for profit, It will not issue any stock, and no part of its assets, income, or earnings shall be distributed to its members, directors, or officers, except for services actually rendered to the corporation. Upon dissolution, all of the assets of the corporation after payment of its just debts shall be transferred or distributed to an organization or organizations as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1954. Notwithstanding any other provision of this Charter, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

XI.

Liability

The property of the corporation shall alone be liable for the payment of its debts and liabilities, and the members shall incur no personal liability for the debts and obligations of the corporation by reason of their membership.

RESOLUTION

RESOLVED, that the Charter of Incorporation of Farrington Alumni and Community Foundation filed with the Office of the Director of Regulatory Agencies, State of Hawaii, on February 25, 1976, and approved by the Director thereof on February 27, 1976 be amended so that Article III and IX thereof read as follows:

1. "III

Purposes

The purposes of the corporation are: to maintain, promote and foster the development of Farrington High School; to grant scholarships, loans and other assistance to young students of promise; to encourage and provide funds for innovative school projects; to provide funds encouraging student and teacher accomplishments such as supplementing travel allowances, recognition dinners, special field trips, and workshops; to promote the general welfare of Farrington High School."

2. "IX

Powers

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried out by a corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code of 1954."

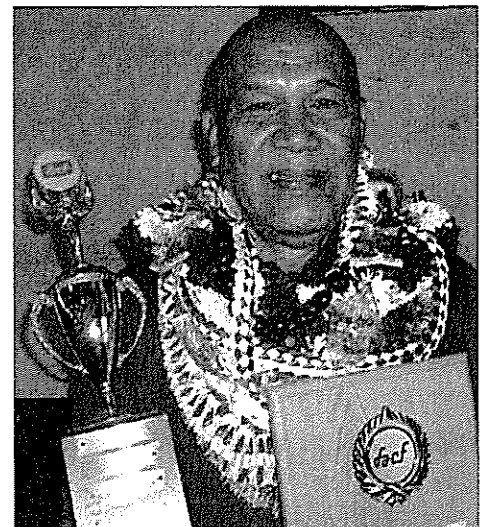

On May 6, 2011, Farrington High kicked off the 75th Anniversary with a spectacular Founder's Day Program, honoring Wallace Rider Farrington and 75 years of deep pride and existence. On August 13, 2011, the School kicked off the school year honoring the 1965 Farrington football team who won (16-6) against Kamehameha School in what was then the ILH Championship. Before the start of the preseason game, both teams were honored and the honorary captains Tom Gushiken, Walter Rodrigues and Stan Cadiente participated in the pregame coin flip. Farrington Alumnus Coach Al Torco, the school's historian, set up a room full of memorabilia that showcased the history of the school.

Vice Principal Angie Koanui, Student Activities Coordinator Theresa Schubert, Teachers Ropati Liua, and Roxanne Kenui, hammered out and coordinated an entertainment card that was diverse, exhilarating,

and electrifying. Our 75th Anniversary Celebration fair showcased a variety of entertainment from Farrington High School, Kalakaua and Dole Middle Schools All Star Programs, and the professional recording artists, "City Side." Band Director Charlie Regua and the Farrington High School band opened up the fair with an inspiring and riveting concert which the audience in awe. The celebration Emcees were Farrington students Diosa Mae Alize and Raymond Ababa who kept the crowd informed, jazzed up, and in the loop at all times. There were three categories: documentary, shorts, and public service announcements.

Documentary winners were: 1st Place - Garrett Higa for "Splash From the Past, Parts 1&2" about the history of the Farrington Swim Team; 2nd Place - Tie between Joyce Quinranilla for "We Care for Rainbows" about the Gay Straight Alliance Club and Taylon Nieto for "Interpretation of Music" about music and dancing; and 3rd Place - Melefusi Fatuaa for "Tongan Girl" about her church and Tongan traditions/culture.

Shorts winners were: 1st Place - Tie between Christopher Nyugen for "School Hunter" about the capture of class council members and Shella Ganoy for "Don't You Hate It When" about irritating moments; and 2nd Place - Tie between Jeremy Garcia for "School Heroes" about super powers and Hazel Faustino for "Fighting for the Amethyst" about a girl becoming a ninja and a leader.

FHS RECEIVES A LIFE SAVING PROGRAM FROM DIAMOND BAKERY

Those who are attending, working, or playing at the Farrington High School can rest a little easier. On Wednesday, May 9th, in an 11 a.m. assembly, Diamond Bakery presented a much-needed automated external defibrillator (AED) to the school, the result of Diamond Bakery's "Have a Heart - Save a Heart" promotion, along with a check for \$2,500 to the American Heart Association of Hawaii.

According to the American Heart Association (AHA), more than 3,000 people die each year from cardiovascular disease in Hawaii. During the presentation, 1,000 FHS students learned the lifesaving technique of CPR and how to use the AED to be better prepared to save the life of someone suffering a cardiac arrest. In most cases, the life saved will be that of a family member.

The assembly was organized and lead by Theresa Ellis' Leadership class with the assistance of local volunteers and AHA instructors. "Our mission is to increase the sudden cardiac arrest survival rate in Hawaii by educating our youth on the key steps needed to save a life" states Pamela Foster, RN, the founder and president of AED Institute and Hawaii Heart Foundation. "Our Heart Safe School program will be implemented in FHS as a part of the donation with the goal to educate everyone on campus this next year on the new CPR and how to use their new life saving device."

SUDDEN CARDIAC ARREST

Sudden Cardiac Arrest is a potentially deadly occurrence that can happen to anyone, of any age at anytime. It's like an electrical system malfunction of the heart when, instead of pumping, the heart just starts quivering or fibrillating and the victim is down immediately because no oxygen is being circulated to the brain. It leads to certain death if nothing is done immediately and it is something that is happening to a lot of young people lately - athletes and non-athletes alike.

It is different from a heart attack in that a heart attack is more like a plumbing problem. A plumbing problem in your home will result in your drains getting clogged, slow drainage, overflows, etc. In your heart, your arteries get clogged; you tire more easily; you might have pain in your chest, arm, shoulders or back. You normally have signs. It can lead to a cardiac arrest if the signs are ignored and the heart is damaged.

As the word suggests, Sudden Cardiac Arrest (SCA) happens unexpectedly. It kills more people annually than all other causes of death put together. A person can be up and talking, doing everything normal and suddenly collapse. Most times, the victim has heart conditions that were previously undiagnosed. However, it can also be caused by blunt trauma at the wrong time...eg: a child getting hit in the chest by a ball or another person, as in baseball, dodgeball or football.

Anyone who has a SCA out of a health facility has almost a 100% chance of dying, unless people around him know what to do. 911 needs to be called and immediate Cardio-Pulmonary Resuscitation (CPR) needs to be performed to keep the blood circulating. The latest CPR calls for chest compressions only - no need to breathe into the victim anymore. Keep it up until emergency services arrive.

And, if there is an Automated External Defibrillator (AED) or "shock machine" around, use it. AED: Automated - it's automatic and will tell you exactly what to do; External - you place it on the out

side of the body - not invasive; Defibrillator - it will stop the heart from fibrillating so the normal heart rhythm will start pumping the heart again. AEDs are located almost everywhere as they have become portable and easy to use. You'll see them at airports, restaurants, shopping centers and many businesses. Don't be afraid. It won't shock the victim if a shock is not needed. Children have been taught how to use it. It is the only thing that can bring the heart back to a normal rhythm.

The first thing you should do if you see someone collapse is to start the Chain of Survival:

1. Tap them and ask if they are OK. If there is no response, tell someone to call 911 and to look for an AED.
2. Push hard and fast in the center of the chest.

In 2009, my only biological child, a 28 year old daughter, special education preschool teacher, was taken from us by Sudden Cardiac Arrest. I had no idea what that was, but soon afterwards, I was fortunate to meet people who taught me about SCA and how CPR and the use of AEDs can help. I thought, "It's so easy, EVERYONE should know," and I started volunteering and spreading awareness about it. Before my husband passed away, 8 months later, he told me I'd be OK because I had my "machines" (the mannequins to teach CPR and the AEDs) and so, the work continues...

My friends have helped by setting up a non-profit foundation, Hawaii Heart Foundation, to help us in our mission of ensuring that our schools and community will be heart safe places.
