The mission of Kai Loa Inc (also referred to herein as KAI LOA) is to help ensure the quality and long-term success of Ke Kula 'o Samuel M. Kamakau, LPCS (also referred to herein as Kamakau), a Preschool-Grade 12 Hawaiian Immersion public charter school. KAI LOA supports Kamakau and fulfills its mission by focusing on three major goals-

- 1. Build capacity for the school's increasing number of qualified teachers and support personnel and strengthening the school's curriculum to meet the growing needs of its students.
- 2. Develop and maintain a planned approach to financial growth to ensure a sustainable source of income.
- 3. Promote parent and community involvement as stakeholders in the school's success.

Ke Kula 'o Samuel M. Kamakau Laboratory Public Charter School is a family-based, Hawaiian language immersion and WASC accredited school offering a comprehensive multi-level (PreK through Secondary) educational program. Kamakau was initially established in January 2000 in response to the expressed needs of Native Hawaiian families to increase student achievement through cultural-based education while addressing the educational needs of multi-generations of learners. As an indigenous language laboratory school program, Ke Kula 'o Kamakau is committed to the ongoing development of Hawaiian language education through research, teacher training, and resource development.

2) The goals and objectives related to the request:

The goal of this request is to complete the renovation of 2 modular buildings – a designated preschool and a computer lab at Ke Kula 'o Samuel M. Kamakau LCPS. Kai Loa is completing the work in 2 phases. The anticipated completion date of Phase I is February 2014. Phase I consisted of the transporting and re-installation of the modular buildings, site work clearing and utilities. This project request is to complete Phase II of the work (final phase), whereby the moduars will be ADA compliant and operational to serve the students, families and staff at Kamakau. This request includes

the installation of aluminum stairs, ADA compliant ramps, walkways, eaves/soffit, and gutters/downspouts, the wiring of communications and data, and paving parking areas and signage and the fencing around the preschool modular. Additionally, architects will be contracted to design a new restroom and kitchen space in the preschool modular and to submit for permits. These additions are necessary to meet the state licensing requirements for preschool classrooms.

The first objective of the request is to decrease the barriers of the community to access affordable quality preschool education at Kamakau and to serve more families in the community. Currently, Kamakau may be the only public PreK-12 school in the state, which creates an advantage of seamless education rooted in the Hawaiian language and cultural practices. The second objective is to maintain Kamakau's 100% graduation and college acceptance rates by continuing to build 21st Century skills for all students in the program as well as to provide computer and internet access to families and the community to broaden their ICT (information and communications technology) literacy skills.

3) The public purpose and need to be served:

Ke Kula 'o Samuel M. Kamakau, LPCS is a public charter school, established to increase student achievement through cultural-based education while addressing the educational needs of multi-generations of learners. It aims to prepare students for success in a global society, to involve families and community as equal partners and perpetuates cultural tradition, knowledge and the Hawaiian language. As a school of choice, Kamakau serves the need of families to be reconnected to the native language of the state and through a curriculum that places extreme value in self-identity, stewardship and a sense of place.

4) Describe the target population to be served:

The target group include Native Hawaiian and other community families and their children who are dedicated to preserving the Hawaiian culture and language through a comprehensive cultural educational experience. The funds being sought are intended to benefit the target group, specifically those with young children, desiring an early education experience designed to develop a strong association with their cultural heritage and the Hawaiian language.

Statistically, the school-community populations are disadvantaged individuals. The current student population at Kamakau include students who are 95% Native Hawaiian and 50% qualify for free-reduced meals. Kamakau's K-12 program is a Title I school, and thus carries extra state requirements to provide these at-risk students additional academic opportunities, qualifying for free or reduced meals.

5) Describe the geographic coverage: Students of Ke Kula 'o Samuel M. Kamakau, LPCS reside in districts throughout the island of O'ahu. A majority of students (66%) reside in Ko'olaupoko while others travel from Honolulu, Ka'a'awa, and the Leeward districts.

II. Service Summary and Outcomes

Describe the scope of work, tasks and responsibilities; Scope

The scope of this work is to complete the detailed finish work on two modular classrooms, one a preschool and the other a computer lab, for Ke Kula 'o Samuel M. Kamakau. Kamehameha Schools (KS) used them as temporary classrooms and donated these buildings to Kamakau in 2012. The work to be performed includes the following tasks-

- · installation of aluminum stairs
- installation of ADA-compliant aluminum ramps
- addition of exterior walkways
- addition of eaves/soffit
- addition of gutters/downspouts
- wiring of communications and data (internet)
- paving parking areas
- · fencing around preschool modular
- installation of signage
- design of the preschool restrooms and kitchen
- retrofitting preschool modular with restrooms and kitchen

Tasks and responsibilities

Contracted Architects will complete the design of the preschool restrooms and kitchen space in the project being requested in Phase II and will submit for permits. A licensed general contractor will provide the finish work. The KAI LOA's finance and facilities committees will control the work and the Executive Director will manage the project.

The Honolulu City and County Department of Planning and Permitting has issued the building permits and will confirm project completion. The Department of Hawaiian Home Lands, as the leaseholder requires copies of all plans. Philadelphia Insurance Companies provides commercial general liability, flood and fire insurance.

KAI LOA's Executive Director will coordinate the work schedule with the contractors and will conduct notifications and make insurance arrangements. The contractor will install the stairs, ramps, walkways and will connect the plumbing to the preschool building. Contractors will also be secured to install the wiring of communications and the data networking system to both modulars. The contractor has already leveled the parking lot site and will coordinate the paving and sidewalk construction.

Move furniture and equipment into classrooms. Coordinate and conduct building and grounds cleaning and planting.

Schedule formal opening of both classrooms with cultural protocol.

Initiate occupancy. Provide overview presentation and tour of the facility to designated staff, parents, and students. Provide operation of appropriate building components, the location of emergency equipment and exits, etc. Turn over the operational and maintenance responsibility to the appropriate staff. Coordinate responses to warranty and post-occupancy construction issues.

Prepare closeout report for grant. Conduct administrative closing for grant.

The KAI LOA facilities committee will visit the work site at least every week to monitor the quality and completion of the work. They will work directly with the Executive Director to initiate discussions with the contractor if there are any concerns or issues. KAI LOA was also granted a \$2.47 mil USDA Rural Development loan, which allowed for the school to move to its new campus in August 2012. KAI LOA's staff and board have successfully managed the development and construction phases of construction thus far and have annually completed an A-133 single audit since 2012. Kai Loa Inc holds a 55-year license at 46-500 Kūneki St in Kāne'ohe on 10 acres of lands owned be the Department of Hawaiian Home Lands (State land) for the operation of Ke Kula 'o Samuel M. Kamakau, LPCS. Current facilities were completed in July 2012, when Kamakau moved to this new school campus. All current facilities in use are ADA compliant.

In December 2012, Kai Loa transported 2 donated modular buildings to the campus. The modulars remain unoccupied and await the completion of renovations. An outcome of this project is completing 2 ADA compliant modular buildings with the installation of aluminum stairs and ramps.
