I. Background and Summary

1. Applicant's background;

The Rehabilitation Hospital of the Pacific (REHAB Hospital) is a 501(c)3 non-profit organization. We provide comprehensive physical and cognitive rehabilitation to individuals that have experienced spinal cord injury, traumatic brain injury, stroke, amputation, complex surgery, serious illness or injury or other trauma. Each year we serve over 5,500 individuals, some of them faced with the most daunting and life-changing challenges of their lives.

2. The goals and objectives related to the request;

The goal of this project has been to renovate REHAB Hospital so patients that experience spinal cord injury, stroke, major multiple trauma, amputation, cardiovascular incident and other illness or injury are able to access quality acute rehabilitation in Hawaii. The facility was built in stages over the past 60 years, and some of the areas of the facility, including the electrical system, were from the original construction in 1953. Over the past two years, the renovation project has brought substantial improvements to the hospital and its patients:

- Improved energy efficiency and electrical system reliability from major upgrades to the hospital electrical system, along with the installation of a rooftop photovoltaic system, new"cool'roofing, energy efficient lighting and a central HVAC system. It is estimated that collectively these improvements will result in a reduction of approximately \$340,000 annually in facility operating expenses;
- Total "gut' renovation of all three inpatient units totaling 70 beds, providing for a more efficient layout and improved environment of care;
- Installation of bedside medical gas and suction, patient lifts and other technology enabling REHAB Hospital to accept some patients who previously may have been transported to the mainland for care;
- Inpatient spaces have been created for new programs and services, including a vision center, cardiac rehabilitation, communication/speech center, and a patient centered healing environment;
- Outdoor therapy area with mobility course and therapeutic garden.

REHAB's inpatient renovations have been completed, so the renovation work now moves to the ground floor. Along with much needed modernization, these improvements will improve our patient's access to care and enhance our patient/customer service.

- New Physicians' Clinic with handicapped-accessible exam and procedure rooms;
- Expanded outpatient waiting areas;

- New way-finding signage to improve patient and visitor access;
- Front desk and patient financial counseling area to enhance patient service:
- Expanded and modernized patient education, conference and staff training rooms;
- New Physicians' Lounge;
- New administrative suite to enhance operational efficiency.

3. State the public purpose and need to be served;

REHAB Hospital contributes significantly to the public good:

Essential medical services. REHAB Hospital is the sole Inpatient Rehabilitation Facility¹ (IRF) in the state, and an essential part of the continuum of medical care for Hawaii residents. Without REHAB Hospital, residents with serious illness or injury would have to be transported to the mainland for care or forego the care they require to recover to their full potential.

Enables the elderly and disabled to live more independently. Intensive and skilled rehabilitation can facilitate the healing process significantly to improve a patient's self-help, mobility and communication skills so that they can return home as independent as possible. For the newly disabled in their young adulthood, skilled and intensive rehabilitation is crucial to recovering to their potential so they can live productive and meaningful lives. For elderly patients, acute rehabilitation can assist them to age in place independently with their best quality of life possible.

Reduces the need for government and private support services and benefits.

The more independent and self sufficient elderly and disabled residents can live, the fewer support services they require from caregivers, government and private organizations, including skilled nursing facilities, caregivers, in home meals and transportation.

Rehabilitation provided to residents with insufficient medical coverage. Over the past five years, REHAB Hospital has provided over \$2 million in charity care to the residents of Hawaii. This financial support enables Hawaii residents that do not have sufficient insurance to receive the medical rehabilitation they require to recover to their greatest potential.

4. Target population to be served;

As the only rehabilitation hospital in the state, this renovation will *benefit all Hawaii residents* that require acute medical rehabilitation. This includes:

- Over 60% of our patients are 65 and older, and the need for acute rehabilitation is anticipated to increase among this age group: Hawaii residents enjoy the longest life expectancy in the country² and by 2030, the U.S. Census Bureau estimates that one in four residents will be an elder. The effects of aging can make a simple injury more complex and rehabilitation can help them age in place longer and with a better quality of life.
- Unanticipated injury from car, work or sports accident (spinal cord injury, traumatic brain injury, amputation, fracture, etc.), or illness (cancer, infection, cardiovascular, stroke) strikes patients of all ages. Patients with spinal cord and traumatic brain injuries are typically younger and rehabilitation is crucial to helping them adapt to challenges and live productively for the rest of their lives.

In 2012, the patient mix for REHAB Hospital included:

- 54% Neurologic—spinal cord injury, traumatic brain injury, stroke and other neurological.
- 30% Complicated Orthopedic—amputation, fracture and joint replacement.
- 16% General Rehabilitation—multiple trauma, complicated cardiovascular surgery, cancer treatment and pulmonary.

5. Geographic coverage.

REHAB Hospital is the only Inpatient Rehabilitation Facility in Hawaii and as a result, serves the entire state. It is also the closest acute rehabilitation facility for patients from the South Pacific, including Guam, Samoa and the Islands of Micronesia.

In addition, approximately 50 patients each year are visitors from around the world that experience recreational accident or illness while on vacation in Hawaii and require care at REHAB Hospital.

II. Service Summary and Outcomes

1. Scope of work, tasks and responsibilities;

Scope of work. This project is to complete the renovation of REHAB Hospital's facilities located at 226 N. Kuakini Street. This 125,200 square foot facility was built in phases since 1953 and has not had any major renovations or improvements for over 15 years. Some of the infrastructure is from the initial construction 60 years ago, including portions of the electrical system.

In FY 2014–2015, renovation of the 1st floor and exteriors will be completed. The tasks include:

- Relocation and expansion of the Physicians' Clinic, including four accessible exam rooms along with a procedure room. Creation of new outpatient waiting area dedicated to the clinic;
- Relocation and expansion of the Nuuanu Outpatient Clinic patient waiting room to increase capacity by more than 50% and improve accessibility;
- Relocation and renovation of Cardiac Rehabilitation gym;
- Construction of new Front Desk and Patient Financial Counseling areas to improve patient flow and improve service to patients and visitors;
- Relocation and expansion of the Gift Shop to improve service to patients, visitors and staff;
- Cosmetic upgrades to all 3 lobbies;
- Expanded signage to improve way-finding and accessibility;
- Reconfigured electrical and network systems and energy efficient lighting;
- Replacement of the air conditioning system to improve the quality of air for inhabitants, lengthen the life of hospital equipment and be more energy efficient. (New air conditioning chillers have already been installed and resulted in an immediate 10% reduction in use of electricity);
- Installation of insulated hurricane-rated windows to enhance emergency preparedness in the event of a natural disaster and improve energy efficiency;
- New Physicians' Lounge to support medical staff development;
- Redesign and improvement of administrative areas to facilitate patient centered care and more efficient staff workflow;
- Expansion and modernizing of patient education, conference and staff training rooms;
- Completion of outdoor mobility course and therapeutic garden to expand and enhance both inpatient and outpatient programs.

2. Projected annual timeline;

Renovation Status and Timeline. The renovation is proceeding on schedule. Construction on the 2nd floor is nearing completion.

3. Quality assurance, evaluation and monitoring

The CEO/owner's representative, together with the architect and general contractor, are responsible for monitoring and evaluating the renovation project. Quality assurance includes the following:

- Weekly status meetings of the owner's representative, architect, plant operations manager and general contractor.
- Monthly reports by the CEO/owner's representative to the Board of Directors of REHAB Hospital to ensure that the project is proceeding in the forecasted timeframe and within the approved budget.
- Ongoing oversight and evaluation by the general contractor to ensure that construction standards are as required by the State of Hawaii and applicable code and that the facility is being constructed per specifications.
- Measures to ensure compliance with applicable labor laws and proper documentation of expenditures.

In addition to the evaluation and monitoring of the renovation, the CEO, CFO and Financing and Contracting Manager work together to ensure that capital campaign revenues and renovation expenses are properly processed on a timely basis and that the project stays within budget. Each year, REHAB Hospital undergoes a financial audit by certified public accountants to ensure that the organization complies with Generally Accepted Accounting Principles.

4. Measurement of effectiveness.

Effectiveness of this project will be determined by the completion of tasks within the projected timeline as evaluated by the owner's representative and architect. See the tasks and timeline for specific details.

III. Financial

REHAB Hospital requests support of \$3.5 million from the Hawaii State Legislature for FY 2014-2015. In FY 2011-2012, REHAB Hospital was awarded a grant of \$2.5 million from the Hawaii State Legislature Grant in Aid program.

The total cost of the project is \$22,860,000. This is an increase of the initial cost estimate made in 2011 of \$17,239,400. This increase is a result of an expansion in the scope of work made in 2012 when leadership of REHAB Hospital changed with the appointment of Dr. Timothy J. Roe as President and CEO and a complete assessment of the renovation was made. The initial construction uncovered numerous problems attributed to the advanced age of the facility and it was determined that a complete replacement of the electrical and air conditioning systems, a new"cool' roof and photovoltaic system would eventually be required in several years. This expanded scope of work will not only reduce the ongoing maintenance costs of the facility, it will also ensure that no other significant renovations or improvements will be required for the inpatient care areas in the foreseeable future.

3. The applicant shall provide a listing of all other sources of funding that they are trying to obtain for fiscal year 2014-2015.

Rehabilitation Hospital of the Pacific Foundation (REHAB Foundation), the fundraising support organization to REHAB Hospital, has a commitment to raise \$17,239,400 for the project, with REHAB Hospital responsible for the balance necessary to complete the renovation. In the past three years, from January 2011 to November 2013, REHAB Foundation raised \$17 million for the renovation. This includes leading private contributions from the Clarence T.C. Ching

Foundation of \$5 million (to be received 2015 to 2024) and The Harry and Jeanette Weinberg Foundation, Inc. of \$3 million (to be received 2013 to 2015). In addition, REHAB Foundation has committed \$2 million of their unrestricted funds to the project.

Although REHAB Foundation will soon reach their capital fundraising goal, REHAB Hospital is responsible for securing the remaining \$5.6 million to complete the renovation.

To ensure that the construction proceeds as planned, REHAB Hospital has secured a \$12 million line of credit from First Hawaiian Bank to cover the cost of the renovation in advance of receipt of capital campaign pledges. First Hawaiian Bank has indicated support to extend this line of credit if necessary.

The Board of Directors has also voted to support the renovation with unrestricted funds, if necessary. However, the declining third party reimbursements and the cost to transition the clinical operations to electronic health records and purchase new technologies require significant capital now and in future years. Funding from the State Legislature Grant in Aid program will enable REHAB Hospital to complete the renovation and continue to serve the people of Hawaii with quality acute rehabilitation so that they do not need to be transported to the mainland for care. This option would be a significantly higher cost to the taxpayers.

4. State and federal tax credits within the prior three years, and state and federal tax credits applied for or anticipate applying for pertaining to the capital project

REHAB Hospital has not received, applied for, and does not anticipate applying for any tax credits pertaining to the renovation.

5. Balance of unrestricted current assets as of November 30, 2013.

Balance is \$7.5 million. The hospital's budgeted operating expense is \$3.24 million per month.

IV. Experience and Capability

A. Necessary Skills and Experience

REHAB Hospital has secured the services of design and construction professionals that are duly licensed and experienced to successfully complete a renovation the size and scope of this project. See the qualifications of key staff and organizations for the renovation in the section below, *V. Personnel: Project Organization and Staffing*.

B. Facilities

The main facility of REHAB Hospital is its 70-bed inpatient hospital in Nuuanu. REHAB Hospital also has three outpatient clinics: Nuuanu at the first floor of the main facility, Aiea at Pearlridge and Hilo. All facilities are ADA compliant.

V. Personnel: Project Organization and Staffing

A. Proposed Staffing, Staff Qualifications, Supervision and Training

Timothy J. Roe, MD, MBA, President and Chief Executive Officer (CEO) represents the hospital regarding ownership decisions on the project including final approval for all activities done by the architect and contractor related to the renovation. He works with the CFO, architect and Project Manager in developing and revising the master budget and master timeline. He is also responsible for communicating with the Board of Directors regarding all pertinent renovation related activities and serves as their fiduciary agent regarding all renovation-related matters. Dr. Roe has previous experience with the planning and construction of healthcare facilities at St. Joseph Regional Rehabilitation Center.

Wendy Manuel, Chief Financial Officer (CFO), is responsible for overseeing all matters relating to capital planning and funding for the renovation project. She also manages the hospital's financial relationships with REHAB Foundation, its banking partners and its vendors and suppliers. She also oversees REHAB's financial operations including revenue cycle, cash flow, assets and liabilities. She has twenty years of experience in public accounting including internal and external audit responsibilities involving multiple major healthcare systems in Hawaii.

Stephen Boyer, Director of Facilities, is responsible for reviewing the specifications of equipment installed during the renovation, particularly owner-supplied equipment such as the nurse call system and Arjo lift. He also coordinates access to the property for multiple contractors involved and ensures that the renovation is not disruptive to the ongoing care of patients. Mr. Boyer has over 15 years of experience managing large facilities, including over six years managing hospital facilities.

Ty Tomimoto, Finance and Contracting Manager, is responsible for reviewing budgetary items related to the project, in particular the invoices and change proposals submitted by the contractors and ensuring that they are consistent with the various contracts executed on behalf of REHAB Hospital. He reviews all contractual agreements and works with the CEO, CFO and Project Manager in the development and revision of the master budget and the master timeline.

Jeff Mori, AIA, of Arthur Mori & Associates (AMA) is the architect for the project. AMA is responsible for the design, drawing plans and working with the general contractor, structural, mechanical and electrical engineers. AMA is also responsible for preparing a detailed schedule for the project in logical steps and budget time required to meet deadlines and for obtaining all necessary permits and licenses.

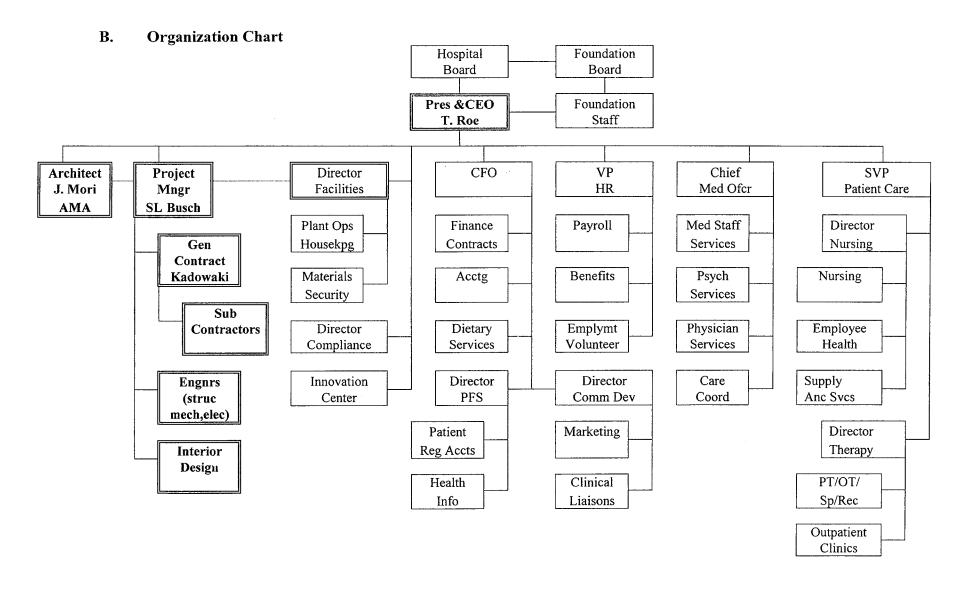
AMA has 51 years of experience providing architectural consulting services in Hawaii. Within the last 19 years, the firm's primary focus has been healthcare design. During that time, more than 350 healthcare related commissions have been successfully completed, including Kapiolani Medical Center, Pali Momi Medical Center, Castle Medical Center, Kuakini Medical Center and Queen's Medical Center. As a result, AMA is well versed in the various codes required of healthcare facilities, including National Fire Prevention Association (NFPA) Code, International Building Code 2003, Uniform Fire Code, National Electric Code, Guidelines for Design and Construction of Health Care Facilities 2006, the Americans with Disabilities Act Accessibility Guidelines and the State of Hawaii Title 11, Dept of Health Chapter 93.

Larry Schenk, S.L. Busch & Associates, Senior Director and Project Manager, is assigned to the project. In this capacity, he coordinates all activities with the REHAB Hospital CEO and architect, and provides overall direction for the renovation. S.L. Busch has extensive experience in management of large scale construction programs, including hospital and healthcare facilities.

J. Kadowaki, Inc., General Contractor, works with the architect and project manager and CEO. The general contractor hires and directs all subcontractors and staff retained for this project. Previous healthcare facilities built by J. Kadowaki, Inc. include Surgicare of Hawaii, On-Care Medical, Kapiolani Medical Center, Queen's POB, Straub Clinics and Hawaii Endoscopy.

Board of Directors, Renovation Committee. REHAB Hospital and REHAB Foundation board members have also formed a committee to oversee the renovation. These board members are: **Stanford Carr**, real estate developer and president of Stanford Carr Development (REHAB Foundation board member since 2007); **Lloyd Sueda**, architect and president of Sueda & Associates, Inc. AIA (REHAB Foundation board member since 2001); and **Ron Ho**, electrical engineer and principal of Ron Ho & Associates (REHAB Hospital board member since 2000).

These special qualifications make REHAB Hospital the only organization in Hawaii that is qualified to treat patients in need of acute medical rehabilitation as a result of serious accident or illness.

REHAB Hospital is an IRS 501(c)3 non-profit organization as determined by the IRS.
