## A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR THE DEPARTMENT OF THE ATTORNEY GENERAL.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that the State of Hawaii
- 5 is involved in several major lawsuits that could result in
- 6 costly judgments against the State if not defended vigorously.
- 7 These major lawsuits will require the State to retain expert
- 8 counsel, expert witnesses, and bear other litigation costs.
- 9 The purpose of this Act is to make an emergency
- 10 appropriation for costs associated with major litigation
- 11 involving the State.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$700,000 or so much
- 14 thereof as may be necessary for fiscal year 2013-2014 to fund
- 15 contracts to retain expert counsel, expert witnesses, and other
- 16 legal services.

- 1 The sum appropriated shall be expended by the department of
- 2 the attorney general for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect upon its approval.
