
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There is appropriated from the source of
3 funding indicated below to departmental administration and
4 budget division (BUF 101) the following sums or so much thereof
5 as may be necessary to fund for fiscal biennium 2013-2015 the
6 Hawaii employer-union health benefits trust fund costs contained
7 in the agreement negotiated with the exclusive bargaining
8 representatives of collective bargaining unit (10):

10 SECTION 2. Funds appropriated by this part shall be
11 allotted by the director of finance to the appropriate state
12 departments for expenditure in the respective fiscal year for
13 the purposes of this part.

15 SECTION 3. There is appropriated from the source of
16 funding indicated below to departmental administration and
17 budget division (BUF 101) the following sums or so much thereof

3 officers and employees in the executive branch excluded from
4 collective bargaining and who belong to the same compensation
5 plans as those officers and employees within collective
6 bargaining unit (10):

10 allotted by the director of finance to the appropriate state
11 departments for expenditure in the respective fiscal year for

14 SECTION 5. Salary increases and cost adjustments provided
15 in this Act for any officer or employee whose compensation is
16 paid, in whole or in part, from federal, special, or other funds
17 shall be paid wholly or proportionately, as the case may be,
18 from the respective funds.

19 SECTION 6. Funds appropriated or authorized by this Act
20 that are not expended or encumbered by June 30, 2014, and June,
21 30, 2015, of the respective fiscal years, shall lapse as of
22 those dates.



1 SECTION 7. This Act shall take effect on July 1, 2050.
