
A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to Program Planning,
4 Analysis, and Budgeting (BUF 101) the following sums or so much
5 thereof as may be necessary to fund for fiscal biennium 2013-
6 2015 all collective bargaining cost items in the agreements
7 negotiated with the exclusive bargaining representatives of
8 collective bargaining unit 13:

2 expenditure for the purposes of this part.

4 SECTION 11. There are appropriated or authorized from the
5 source of funding indicated below to hospital care -- Hawaii
6 health systems corporation (HTH 210) the following sums or so
7 much thereof as may be necessary to fund for fiscal biennium
8 2013-2015 the salary increases and other cost adjustments
9 authorized by chapter 89C, Hawaii Revised Statutes, for state
10 officers and employees assigned to the Hawaii health system
11 corporation who are excluded from collective bargaining:

20 in this Act for any officer or employee whose compensation is
21 paid, in whole or in part from federal, special, or other funds



1 shall be paid wholly or proportionately as the case may be, from
2 the respective funds.

3 SECTION 14. Funds appropriated or authorized by this Act
4 that are not expended or encumbered by June 30, 2014, and June
5 30, 2015, of the respective fiscal years, shall lapse as of
6 those dates.

7 SECTION 15. This Act shall take effect on July 1, 2013.
