
A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) The office of elections shall develop and
2 implement a statewide voting modernization program that shall:

3 (1) Apply to all elections, as that term is defined in
4 section 11-302, Hawaii Revised Statutes, held in the
5 State beginning in 2016;

6 (2) Require all registered voters to vote by mail;

7 (3) Provide for limited voting at polling places and
8 election day registration pursuant to subsections (b)
9 and (c); and

10 (4) Provide voter education materials relating to the
11 program.

12 (b) In implementing the program, the office of elections
13 shall make a sufficient number of polling places available:

14 (1) For voters who the office of elections determines are
15 unable to vote by mail because of the lack of a
16 permanent mailing address or any other reason that the
17 office of elections deems appropriate;



- 1 (2) To accommodate election day voter registration and
2 voting pursuant to subsection (c); and
3 (3) To receive ballots deposited by voters in lieu of mail
4 delivery.

5 (c) In implementing the program, the office of elections
6 shall ensure that each individual who is eligible to vote may
7 register on election day by appearing in person at the polling
8 place designated by the office of elections, completing an
9 affidavit on application for voter registration, and providing
10 proof of identity and residence in the form and manner
11 prescribed by the office of elections.

12 SECTION 2. No later than twenty days prior to the
13 convening of the 2014 regular session, the office of elections
14 shall submit a report to the legislature that includes:

- 15 (1) The current status of implementation of the voting
16 modernization program;
17 (2) A brief description of any operational problems or
18 legal impediments that have affected or are
19 anticipated to affect implementation of the program;
20 and
21 (3) Any proposed legislation to implement the program.

1 SECTION 3. There is appropriated out of the general
 2 revenues of the State of Hawaii the sum of \$250,000 or so much
 3 thereof as may be necessary for fiscal year 2013-2014 and the
 4 same sum or so much thereof as may be necessary for fiscal year
 5 2014-2015 for the voting modernization program required by this
 6 Act.

7 The sums appropriated shall be expended by the office of
 8 elections for the purposes of this Act.

9 SECTION 4. This Act shall take effect on July 1, 2013.
