# A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to the department of budget  
4 and finance, departmental administration and budget division  
5 (BUF 101), the following sums or so much thereof as may be  
6 necessary to fund for fiscal biennium 2013-2015, the Hawaii  
7 employer-union health benefits trust fund costs and other cost  
8 adjustments contained in the agreement negotiated with the  
9 exclusive bargaining representative of collective bargaining  
10 unit (5):

11 FY 2013-2014 FY 2014-2015

12 General funds

13 Special funds

14 Federal funds

15 Other funds

16 SECTION 2. Funds appropriated or authorized by this part  
17 shall be allotted by the director of finance to the appropriate



1 state departments for expenditure in the respective fiscal year  
2 for the purposes of this part.

3 PART II

4 SECTION 3. There are appropriated or authorized from the  
5 sources of funding indicated below to the department of budget  
6 and finance, departmental administration and budget division  
7 (BUF 101), the following sums or so much thereof as may be  
8 necessary to fund for fiscal biennium 2013-2015, the Hawaii  
9 employer-union health benefits trust fund costs and other cost  
10 adjustments authorized by chapter 89C, Hawaii Revised Statutes,  
11 for state officers and employees excluded from collective  
12 bargaining who belong to the same compensation plans as those  
13 officers and employees within collective bargaining unit (5):

19 SECTION 4. Funds appropriated or authorized by this part  
20 shall be allotted by the director of finance to the appropriate  
21 state departments for expenditure in the respective fiscal year  
22 for the purposes of this part.

2 SECTION 5. Collective bargaining cost items and cost  
3 adjustments provided in this Act for any officer or employee  
4 whose compensation is paid, in whole or in part, from federal,  
5 special, or other funds shall be paid wholly or proportionately,  
6 as the case may be, from the respective funds.

7 SECTION 6. Funds appropriated or authorized by this Act  
8 that are not expended or encumbered by the end of the fiscal  
9 year for which the appropriation or authorization is made, shall  
10 lapse as of those dates.

11 SECTION 7. This Act shall take effect on July 1, 2013.
