
A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that during the late
2 1960s and early 1970s, Hawai'i experienced a grassroots movement
3 to revitalize the native Hawaiian culture, which also led to
4 demands for Hawai'i-oriented courses in Hawai'i's public schools
5 and colleges.

6 At the same time, proponents of the movement acknowledged a
7 risk of losing native knowledge of the Hawaiian language,
8 culture, and history permanently with many traditional kupuna
9 being of advanced age and rapidly dwindling in numbers. This
10 prompted the 1978 constitutional convention to propose a
11 Hawaiian education program that, upon approval by the voters,
12 became article X, section 4, of the Hawaii State Constitution
13 which, among other things, requires the State to promote the
14 study of Hawaiian culture, history, and language and provide for
15 a Hawaiian education program consisting of language, culture,
16 and history in the public schools.



1 The legislature further finds that there are concerns that
2 the Hawaiian education programs in the public schools are
3 disjointed, lack appropriate oversight, and are not provided
4 adequate resources in order to meet the purpose and intent of
5 article X, section 4, of the Hawaii State Constitution.

6 The purpose of this Act is to create the instructional
7 office of Hawaiian studies for the purpose of providing
8 instruction to public school students on Hawaiian history,
9 culture, arts, and language and to oversee Hawaiian education
10 programs in the public schools.

11 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
12 amended by adding a new section to be appropriately designated
13 and to read as follows:

14 "§302A- Instructional office of Hawaiian studies. (a)
15 There is established within the department an instructional
16 office of Hawaiian studies for the purpose of providing
17 instruction to public school students on Hawaiian history,
18 culture, arts, and language. The office shall have direct
19 oversight and responsibility for:

20 (1) All components of the Hawaiian education program
21 established pursuant to article X, section 4, of the
22 Hawaii State Constitution; and



1 (2) The Hawaiian language medium education program
2 established pursuant to chapter 302H.

3 The office may assist public charter schools governed by
4 chapter 302D in providing instruction to students on Hawaiian
5 history, culture, arts, and language if these topics are part of
6 the charter school's curriculum.

7 (b) The instructional office of Hawaiian studies, Hawaiian
8 education program established pursuant to article X, section 4,
9 of the Hawaii State Constitution, and the Hawaii language medium
10 education program established pursuant to chapter 302H, shall be
11 separate budget line items in the biennial and supplemental
12 state budget."

13 SECTION 3. Section 302A-630, Hawaii Revised Statutes, is
14 amended by amending subsection (d) to read as follows:

15 "(d) In determining additional benefits for teachers,
16 staff, and administrators in Hawaiian language medium education,
17 the department, in consultation with the instructional office of
18 Hawaiian studies, may allow credit for practical experience."

19 SECTION 4. There is appropriated out of the general
20 revenues of the State of Hawaii the sum of \$ or so
21 much thereof as may be necessary for fiscal year 2014-2015 for
22 the establishment of the instructional office of Hawaiian



1 studies and for the office to carry out its duties and functions
2 pursuant to this Act.

3 The sum appropriated shall be expended by the department of
4 education for the purposes of this Act.

5 SECTION 5. New statutory material is underscored.

6 SECTION 6. This Act shall take effect upon its approval;
7 provided that section 4 shall take effect on July 1, 2014.
