
A BILL FOR AN ACT

RELATING TO THE COMPOSITION OF THE BOARD OF LAND AND NATURAL
RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 26-15, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) The department of land and natural resources shall be
4 headed by an executive board to be known as the board of land
5 and natural resources, except for matters relating to the state
6 water code where the commission on water resource management
7 shall have exclusive jurisdiction and final authority.

8 The board shall consist of seven members, one from each
9 land district and three at large. The appointment, tenure, and
10 removal of the members and the filling of vacancies on the board
11 shall be as provided in section 26-34. At least one member of
12 the board shall have a background in conservation and natural
13 resources, as provided in section 171-4. At least one member,
14 other than the member with a background in conservation and
15 natural resources, shall have demonstrated expertise in native
16 Hawaiian traditional and customary practices, as provided in
17 section 171-4.



1 The governor shall appoint the chairperson of the board
2 from among the members thereof.

3 The board may delegate to the chairperson such duties,
4 powers, and authority, or so much thereof, as may be lawful or
5 proper for the performance of the functions vested in the board.

6 The chairperson of the board shall serve in a full-time
7 capacity. The chairperson, in that capacity, shall perform
8 those duties, and exercise those powers and authority, or so
9 much thereof, as may be delegated by the board."

10 SECTION 2. Section 171-4, Hawaii Revised Statutes, is
11 amended to read as follows:

12 "**§171-4 Board of land and natural resources; terms and**
13 **qualifications of members of the board; organization; expenses.**

14 (a) The board of land and natural resources shall be composed
15 of seven members, one from each land district and three at
16 large, to be nominated and, by and with the advice and consent
17 of the senate, appointed by the governor as provided in section
18 26-34. The term and removal of a member of the board and the
19 filling of a vacancy on the board shall also be as provided in
20 section 26-34. There shall be not more than three members on
21 the board from the same political party.



1 (b) At least one member of the board shall have a
2 background in conservation and natural resources, as evidenced
3 by:

- 4 (1) A college degree in a relevant field, including
5 forestry, wildlife conservation, geology,
6 environmental science, or marine biology; or
7 (2) Work history sufficient to demonstrate an appropriate
8 level of knowledge in the subject of land and natural
9 resources, including parks and recreation, public
10 lands management, natural area reserves, aquatic
11 resources, boating and recreation, forestry and
12 wildlife, water resources management, or conservation
13 and resources.

14 (c) At least one member of the board, other than the
15 member appointed pursuant to subsection (b), shall have
16 demonstrated expertise in native Hawaiian traditional and
17 customary practices, as evidenced by:

- 18 (1) A college degree in a relevant field, such as Hawaiian
19 studies, native Hawaiian law, native Hawaiian
20 traditional and customary practices, or related
21 subject area;



1 (2) Work history that demonstrates an appropriate level of
2 knowledge in native Hawaiian traditional and customary
3 practices; or

4 (3) Substantial experience as a native Hawaiian
5 traditional and customary practitioner.

6 ~~(b)~~ (d) Each member shall disclose and file with the
7 board a list of all transactions with the department of land and
8 natural resources in which the member has a direct interest.

9 The member shall also disclose all transactions with the
10 department involving any corporation, association, partnership,
11 or joint venture in which the member is an officer, partner, or
12 employee. Any member having any interest, direct or indirect,
13 in any matter before the board shall disqualify oneself from
14 voting on or participating in the discussion of the matter.

15 ~~(c)~~ (e) The governor shall select a chairperson of the
16 board from among its members. The chairperson shall call and
17 preside at meetings and may appoint a member of the board as
18 secretary. The members of the board shall choose one of their
19 number to act as chairperson during the absence or disability of
20 the chairperson.

21 ~~(d)~~ (f) The members of the board shall serve without pay
22 but shall be entitled to reimbursement for necessary expenses



1 while attending meetings and while in the discharge of their
2 duties."

3 SECTION 3. Statutory material to be repealed is bracketed
4 and stricken. New statutory material is underscored.

5 SECTION 4. This Act shall take effect on July 1, 2030, and
6 shall apply to the board of land and natural resources upon its
7 next vacancy.
