
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
2 amended by adding a new section to part V to be appropriately
3 designated and to read as follows:

4 "§304A- Consolidated report. (a) The University of
5 Hawaii shall submit an annual consolidated report to the
6 legislature, no later than twenty days prior to the convening of
7 each regular session, containing the following:

8 (1) Annual financial statements;

9 (2) Non-general fund revenues and expenditures by fund
10 type;

11 (3) Positions and salaries by collective bargaining unit;

12 (4) The information required by sections 304A-1004, 304A-
13 2153, and 304A-2689; and

14 (5) Any other information required by statute; provided
15 that the statute states that the information shall be
16 reported pursuant to this section.

17 (b) Unless specifically exempted from this section, the
18 report submitted pursuant to subsection (a) may include any



1 other information required in other University of Hawaii annual
2 reports required to be submitted to the legislature and, if the
3 information is included, shall be considered as the official
4 report to the legislature for that respective reporting
5 requirement."

6 SECTION 2. Section 304A-1004, Hawaii Revised Statutes, is
7 amended to read as follows:

8 " ~~[f]§304A-1004[f]~~ **Annual report; executive, managerial,**
9 **and faculty salaries.** The ~~[board of regents]~~ University of
10 Hawaii shall submit an annual report ~~[to the legislature]~~
11 pursuant to section 304A- , containing the salaries paid to
12 all executive, managerial, and faculty members of the
13 university, including that paid to the president of the
14 university~~[, not fewer than twenty days prior to the convening~~
15 ~~of each regular session]~~ ."

16 SECTION 3. Section 304A-2153, Hawaii Revised Statutes, is
17 amended by amending subsection (b) to read as follows:

18 "(b) Any law to the contrary notwithstanding, the board of
19 regents may authorize expenditures of up to \$3,000,000 annually,
20 excluding in-kind services, from this fund for the purposes of
21 promoting alumni relations and generating private donations for
22 deposit into the University of Hawaii Foundation for the



1 purposes of the university. Any expenditure authorized pursuant
2 to this subsection shall be for a public purpose and shall not
3 be subject to chapters 42F, 103, 103D, and 103F. [~~The~~] Pursuant
4 to section 304A- , the university shall submit a comprehensive
5 annual report to the legislature detailing the use of any funds
6 authorized by the board under this subsection [~~no later than~~
7 ~~twenty days prior to the convening of each regular session~~].

8 The report shall:

- 9 (1) Identify each department of the University of Hawaii
10 Foundation supported by moneys from the fund;
- 11 (2) Describe the purposes and activities of each
12 department identified in paragraph (1) and how it
13 participates in fundraising activities and benefits
14 the university;
- 15 (3) Provide the total expenditures of each department
16 identified in paragraph (1) by primary expense
17 categories;
- 18 (4) Identify all moneys from the fund transferred to any
19 fund of the university and provide a justification of
20 how these moneys are used to benefit the university;
- 21 (5) Provide a financial summary of the operating
22 activities of the University of Hawaii Foundation,



1 including revenues and expenditures by major reporting
2 categories; and
3 (6) Identify amounts and purposes of all expenditures from
4 the University of Hawaii support fund."

5 SECTION 4. Section 304A-2689, Hawaii Revised Statutes, is
6 amended to read as follows:

7 " ~~[+]§304A-2689[+]~~ **Annual report.** ~~[The University of~~
8 ~~Hawaii shall submit a report to the legislature, no later than~~
9 ~~twenty days prior to the convening of each regular session, of~~
10 ~~all]~~ All revenue bonds issued pursuant to this subpart~~(-)~~ shall
11 be reported pursuant to section 304A-_____. The annual report
12 shall provide a summary of all revenue bonds issued pursuant to
13 this subpart during the preceding fiscal year."

14 SECTION 5. Statutory material to be repealed is bracketed
15 and stricken. New statutory material is underscored.

16 SECTION 6. This Act shall take on July 1, 2525.
