
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRTY-FIFTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2014-2015:

5 1. To be expended by the department of education:

6 A. Waipahu intermediate school, Oahu

7 Design for new eight-classroom building, ground and
8 site improvements, and equipment and appurtenances.

9 Design \$300,000

11 B. Waipahu intermediate school, Oahu
