
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Sand Island state recreation area is
2 located makai of the dense urban and key shipping core of
3 Honolulu and represents one of the last remaining public
4 recreational venues in an otherwise hardened and inaccessible
5 shoreline consisting of development and commercial activity.
6 This one hundred forty acre park has a 2.75 mile long shoreline
7 with access to safe ocean water and channels, comfort stations,
8 picnic shelters, and boat launching features. While
9 approximately one hundred acres of the park are developed and
10 managed for day use and camping, approximately forty acres are
11 open land with trails and tracks created for authorized and
12 temporary off-highway vehicle use. This area is adjacent to a
13 shoreline that is well suited for canoe paddling and a variety
14 of other passive ocean uses.

15 The department of land and natural resources, through the
16 divisions of state parks and boating and ocean recreation,
17 manages this land area and adjacent water for a variety of
18 passive land and ocean recreational activities including



1 picnicking, camping, running, fishing, swimming, surfing,
2 baseball, off highway vehicle use, canoe paddling, and boating.
3 Since 1973, when a plan was first adopted for the area, there
4 have been a variety of alternative and competing proposals for
5 this largely-undeveloped parcel. However, inadequate
6 operational funds, a harsh physical climate, and an oftentimes
7 damaging social environment have contributed to decay of the
8 area and have caused the need for frequent repairs to its
9 infrastructure.

10 The legislature finds that it is imperative to not only
11 preserve the rare pockets of urban recreational spaces,
12 including Sand Island state recreation area, that serve Oahu's
13 growing population but to also enhance those areas with
14 fundamentally safe and managed access and infrastructure.
15 Further, the growing awareness of the imminent, obvious impact
16 that climate change will have on Hawaii as an ocean state makes
17 it imperative that plans for public shoreline use incorporate
18 plans for future adaption to rising sea levels.

19 Therefore, the legislature finds that an investment is
20 warranted in sustainable and fundamental infrastructure such as
21 roadway access, parking facilities, utilities, showers, and
22 comfort stations to establish the basic requirements for



1 ensuring that passive ocean recreation in the remaining
2 undeveloped portion of Sand Island state recreation area remains
3 available.

4 SECTION 2. There is appropriated out of the general
5 revenues of the State of Hawaii the sum of \$1,200,000 or so much
6 thereof as may be necessary for fiscal year 2014-2015 for
7 planning for infrastructure for the passive recreation area of
8 Sand Island state recreation area.

9 The sum appropriated shall be expended by the department of
10 land and natural resources for the purposes of this Act.

11 SECTION 3. This Act shall take effect on July 1, 2050.
