
A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 286, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§286- Reciprocal licensing privileges. (a) A
5 nonresident operator of a motor vehicle who is the holder of a
6 license to operate a motor vehicle in the country in which the
7 nonresident operator resides is not required to obtain a
8 driver's license to operate a passenger car or truck, as those
9 terms are defined in section 286-2, classified as category 3
10 under section 286-102, within this State, if the operator does
11 not receive compensation for the operation of the category 3
12 passenger car or truck; provided that:

13 (1) The director determines that the standards of the
14 other country for licensing operators correspond
15 substantially to those of this State and that the
16 other country extends the same privileges to persons
17 licensed to operate motor vehicles by this State; and



1 (2) The director and the other country have exchanged
2 written agreements confirming the reciprocal extension
3 of privileges to operate motor vehicles.

4 (b) The director shall publish on its public internet site
5 a list of the countries for which reciprocal operating
6 privileges have been extended and those that have been
7 withdrawn. The most recent list shall be transmitted to the
8 courts, county prosecuting attorneys, and county police chiefs.

9 (c) The director may adopt rules pursuant to chapter 91
10 necessary for the purposes of this section."

11 SECTION 2. Section 286-11, Hawaii Revised Statutes, is
12 repealed.

14 ~~The director shall establish a statewide driver's license~~
15 ~~reciprocity committee consisting of one representative from the~~
16 ~~department of transportation and the chief examiner of drivers~~

18 ~~whenever a foreign country makes a request for driver's license~~

4 ~~committee shall serve voluntarily and without compensation, but~~

7 ~~on the committee. The costs shall be paid by the department of~~
8 ~~transportation.~~

9 ~~(d) In the event that there is available from the~~
10 ~~requesting foreign country an evaluation of that country's~~
11 ~~driver's license requirements prepared by another United States~~
12 ~~driver licensing agency or the American Association of Motor~~
13 ~~Vehicle Administrators, the statewide driver's license~~
14 ~~reciprocity committee shall conduct a comparison review of the~~
15 ~~evaluation and the State's driver licensing examination~~
16 ~~standards and submit a written recommendation to the legislature~~
17 ~~no later than twenty days prior to the convening of the regular~~
18 ~~legislative session immediately subsequent to the review.~~

19 ~~(e) If there is no such evaluation available from the~~
20 ~~requesting foreign country, the director may select from the~~
21 ~~statewide driver's license reciprocity committee the~~
22 ~~representative from the department of transportation and a~~

 2 ~~requesting foreign country, at the expense of the requesting~~
 3 ~~foreign country, to inspect and examine the foreign country's~~
 4 ~~driver's license examination program and advise the committee of~~
 5 ~~their findings. The committee shall review the findings and~~
 6 ~~submit a written recommendation to the legislature on whether~~
 7 ~~the foreign country's driver's license examination standards~~
 8 ~~correspond to Hawaii's driver's license examination standards no~~
 9 ~~later than twenty days prior to the convening of the regular~~
 10 ~~legislative session immediately subsequent to the travel and~~
 11 ~~evaluation by the driver's license reciprocity committee.~~

12 ~~(f) The director shall adopt rules pursuant to chapter 91~~
 13 ~~necessary for the purposes of this section."]~~


14 SECTION 3. Statutory material to be repealed is bracketed
