# A BILL FOR AN ACT

RELATING TO HUMAN TRAFFICKING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 706, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	"§706- Human trafficking victim services fund. (1) In		
5	addition to any disposition authorized by chapter 706 or 853,		
6	any individual who is:		
7	(a) Convicted of an offense under part VIII of chapter		
8	707; or		
9	(b) Convicted of an offense under part I of chapter 712,		
10	shall be ordered to pay a fee under subsection (2).		
11	(2) Fees for individuals subject to subsection (1) shall not		
12	exceed the following:		
13	(a) \$ when the offense is a class A felony;		
14	(b) \$ when the offense is a class B felony;		
15	(c) \$ when the offense is a class C felony;		
16	(d) \$ when the offense is a misdemeanor; or		
17	(e) \$ when the offense is a petty misdemeanor.		

There is established within the state treasury a special 1 (3) 2 fund to be known as the human trafficking victim services fund to be administered by the department of labor and industrial 3 relations. The disbursement of money from the human trafficking 4 victim services fund shall be used to supplement programs, 5 6 grants, or purchase of service contracts that support or provide comprehensive services to victims of labor trafficking crimes 7 under part VIII of chapter 707, or victims of trafficking 8 related to crimes under part I of chapter 712. Moneys in the 9 10 special fund shall be used for new or existing programs, grants, or purchase of service contracts and shall not supplant any 11 other moneys previously allocated to these programs, grants, or 12 13 purchase of service contracts. (4) All fees paid and interest accrued on funds collected 14 pursuant to this section shall be deposited into the human 15 trafficking victim services fund. 16 (5) Pursuant to section 706-605, any crime victim 17 compensation fees imposed under part III of chapter 706, 18 restitution imposed by section 707-785 or 707-786, and probation 19 fees shall be paid before payment of the fee under subsection 20

11	SECT	ION 2. This Act does not affect rights and duties that
12	matured,	penalties that were incurred, and proceedings that were
13	begun bef	ore its effective date.
14	SECT	ION 3. New statutory material is underscored.
15	SECT	ION 4. This Act shall take effect on July 1, 2300.
