A BILL FOR AN ACT

RELATING TO COMMUNITY FOOD FORESTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the number of food
- 2 stamp recipients in Hawaii has nearly doubled over the last six
- 3 years. The legislature also acknowledges that Hawaii residents
- 4 face among the highest costs in the nation, with the inflation
- 5 of cost-of-living often outpacing the growth of provisional
- 6 rates for state welfare.
- 7 The legislature further finds that due to the island
- 8 geography of Hawaii, the long-term sustainability of the State
- 9 depends upon improved uses of land that has already been
- 10 developed. The legislature also finds that food production in
- 11 populated areas may contribute significantly to community
- 12 sustainability by providing locally-produced healthy food to
- 13 those who can not otherwise afford it.
- 14 Community and urban gardens, concepts which have been
- 15 adopted statutorily in states like New York, California,
- 16 Massachusetts, Tennessee, and Maine, may provide a solution to
- 17 the problem of increasing food costs and the dwindling
- 18 availability of undeveloped land. By identifying and utilizing



- 1 public lands, particularly those near existing community
- 2 gathering places such as parks and community centers, to create
- 3 community food forests that adopt edible landscaping concepts,
- 4 the State may be able to provide additional sources of low- or
- 5 no-cost food to residents, while also utilizing developed land
- 6 for community sustainability purposes.
- 7 Accordingly, the purpose of this Act is to establish a
- 8 community food forest program and to make an appropriation for
- 9 this program.
- 10 SECTION 2. Chapter 171, Hawaii Revised Statutes, is
- 11 amended by adding a new section to be appropriately designated
- 12 and to read as follows:
- 13 "S171- Community food forest program. (a) The
- 14 department shall establish and maintain a community food forest
- 15 program.
- 16 (b) The community food forest program shall develop a
- 17 statewide network of locally-directed community food forests in
- 18 viable locations around the State by working with the various
- 19 county governments and community-based citizen organizations to:
- 20 (1) Identify potential locations such as parks, community
- 21 centers, or other locations that may be suitable for

16	community	food forests will be placed, the department of
17	agricultu	re, and other state and county government agencies and
18	private o	rganizations concerned with the development of
19	community	food forests.
20	<u>(e)</u>	The community food forest program shall report to the
21	legislatu	re no later than twenty days prior to the convening of
22	each regu	lar session, beginning with the regular session of

- 2 including a review of potential community food forest locations
- 3 and the amount of community involvement in each potential
- 4 community food forest location.
- 5 (f) For the purposes of this section:
- 6 "Plant" means any member of the plant kingdom, which bears
- 7 edible fruit, seeds, or roots."
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year 2014-2015 for the
- 11 establishment of a community food forest program.
- 12 The sum appropriated shall be expended by the department of
- 13 land and natural resources for the purposes of this Act.
- 14 SECTION 4. New statutory material is underscored.
- 15 SECTION 5. This Act shall take effect on July 1, 2014.
