BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 195D-25, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) There is established within the department for
4	administrative purposes only, the endangered species recovery
5	committee, which shall serve as a consultant to the board and
6	the department on matters relating to endangered, threatened,
7	proposed, and candidate species. The committee shall consist of
8	two field biologists with expertise in conservation biology, \underline{a}

10	and customary practices, the chairperson of the board or the
11	chairperson's designee, the ecoregion director of the United
12	States Fish and Wildlife Service or the director's designee, the
13	director of the United States Geological Survey, Biological
14	Resources Division or the director's designee, and the director
15	of the University of Hawaii Environmental Center or the
16	director's designee.
17	Nongovernmental members shall be appointed by the governor
18	pursuant to section 26-34. Nongovernmental members shall not

1	serve for more than two consecutive terms. Nongovernmental
2	members shall serve for four-year staggered terms, except that
3	one of the members first appointed shall serve for two years.
4	Governmental members from the federal agencies are
5	requested but not required to serve on the committee. The
6	ability of the committee to carry out its functions and purposes
7	shall not be affected by the vacancy of any position allotted to
8	a federal governmental member."

PURPOSE:

To amend the composition of the Endangered Species Recovery Committee by adding a member possessing a background in native Hawaiian traditional and customary

practices.

MEANS:

Amend section 195D-25(a), Hawaii Revised

Statutes.

JUSTIFICATION:

Native Hawaiian culture has knowledge that has been passed on for generations and is still practiced for the purpose of perpetuating traditional protocols, caring for and protecting the environment, and strengthening cultural and spiritual connections.

Pursuant to various statutes, nearly all the boards and commissions under the jurisdiction of the Department of Land and Natural Resources (Department) require a member with a background in native Hawaiian traditional and customary practices. Currently however, the Endangered Species Recovery Committee does not include a member with a background in native Hawaiian traditional and customary practices.

Incorporating members with such a background on the Endangered Species Recovery Committee would provide an opportunity for valuable knowledge of native Hawaiian traditional and customary practices to be included in decisions regarding endangered species of significance to the native Hawaiian culture.

Impact on the public: This bill would allow the public to benefit from knowledge of native Hawaiian traditional and customary



practices with regard to decisions affecting endangered species.

Impact on the department and other agencies:
This bill would provide the Department with valuable knowledge of native Hawaiian traditional and customary practices with regard to decisions affecting endangered species.
