## A BILL FOR AN ACT

RELATING TO TEMPORARY DISABILITY BENEFITS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 392-3, Hawaii Revised Statutes, is  
2 amended by amending the definition of "disability" to read as  
3 follows:

4           "Disability" means total inability of an employee to  
5 perform the duties of the employee's employment caused by  
6 sickness, pregnancy, termination of pregnancy, organ donation,  
7 or accident other than a work injury as defined in section 386-  
8 3."

9           SECTION 2. Section 392-21, Hawaii Revised Statutes, is  
10 amended by amending subsection (a) to read as follows:

11           "(a) Any individual in current employment who suffers  
12 disability resulting from accident, sickness, pregnancy, [~~or~~]  
13 termination of pregnancy, or organ donation, except accident or  
14 disease connected with or resulting from employment as defined  
15 in section 386-3 or any other applicable workers' compensation  
16 law, shall be entitled to receive temporary disability benefits  
17 in the amount and manner provided in this chapter."



1 SECTION 3. Statutory material to be repealed is bracketed  
2 and stricken. New statutory material is underscored.

3 SECTION 4. This Act shall take effect upon its approval.
