
A BILL FOR AN ACT

RELATING TO THE REPEAL OF NON-GENERAL FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 142-28.5, Hawaii Revised Statutes, is
2 repealed.

3 [~~"§142-28.5 Animal quarantine special fund. There is~~
4 ~~established the animal quarantine special fund to be~~
5 ~~administered by the board of agriculture. Moneys received by~~
6 ~~the board of agriculture from:~~

7 (1) ~~Fees for the quarantine of cats, dogs, and other~~
8 ~~carnivores pursuant to this chapter;~~

9 (2) ~~Moneys received for the use of animal quarantine~~
10 ~~property or facilities pursuant to section 142-3.5; or~~

11 (3) ~~State appropriations or other moneys made available,~~
12 ~~shall be deposited into the special fund. All interest earned~~
13 ~~or accrued on moneys deposited in the special fund shall become~~
14 ~~part of the special fund. Moneys in the special fund shall be~~
15 ~~expended to cover all costs of quarantine but not limited to the~~

6 SECTION 2. The following funds are abolished:

- 7 (1) The donations for voter registration drive trust
8 account established in 1984 and administered by the
9 department of accounting and general services;
- 10 (2) The Hawaii FYI - ICSD trust account administratively
11 established in 1996 and administered by the department
12 of accounting and general services;
- 13 (3) The parking control revolving fund escrow account
14 revolving fund administered by the department of
15 accounting and general services;
- 16 (4) The returned ACH tax refunds trust account
17 administratively established in 2004 and administered
18 by the department of accounting and general services;
- 19 (5) The HDOA biocontrol foreign exploration special fund
20 created in 2010 and administered by the department of
21 agriculture; and



1 (6) The Hawaii EUTF self-directed investments trust
2 account created in 2007 and administered by the
3 department of budget and finance,
4 and any remaining balances shall be transferred to the general
5 fund.

6 SECTION 3. On June 30, 2014, all unencumbered balances
7 remaining in the accounts and funds repealed by this Act shall
8 lapse to the credit of the general fund.

9 SECTION 4. Statutory material to be repealed is bracketed
10 and stricken.

11 SECTION 5. This Act shall take effect on July 1, 2014.
