
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII AT HILO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that pursuant to
2 S.C.R. No. 132, S.D. 1, regular session of 2013, the University
3 of Hawaii at Hilo, through its 'Imiloa astronomy center and
4 division of academic affairs, has entered into a memorandum of
5 understanding with the RISE 21st Century After School Program, a
6 program that helps underprivileged children of Hawaiian ancestry
7 with life skills, academic achievement, and career planning.

8 Pursuant to the memorandum of understanding:

9 (1) The University of Hawaii at Hilo will provide
10 individual mentoring to assist RISE 21st Century After
11 School Program participants with academic achievement
12 and career planning;

13 (2) The University of Hawaii at Hilo and the RISE 21st
14 Century After School Program will collaborate to
15 develop and offer project-based activities that foster
16 and encourage peer mentoring while addressing relevant
17 community initiatives; and



1 (3) The University of Hawaii at Hilo and the RISE 21st
 2 Century After School Program will collaborate on
 3 funding initiatives to support collaborative goals and
 4 objectives.

5 The purpose of this Act is to appropriate funds to the
 6 University of Hawaii at Hilo to establish staff positions within
 7 the 'Imiloa astronomy center and support the University of Hawaii
 8 at Hilo's memorandum of understanding with the RISE 21st Century
 9 After School Program.

10 SECTION 2. There is appropriated out of the general
 11 revenues of the State of Hawaii the sum of \$ or so much
 12 thereof as may be necessary for fiscal year 2014-2015 to the
 13 University of Hawaii at Hilo for the following:

- 14 1. One full-time equivalent (1.0 FTE)
 15 youth development specialist \$
- 16 2. One full-time equivalent (1.0 FTE)
 17 education specialist/K-6
 18 outreach coordinator \$
- 19 3. One full-time equivalent (1.0 FTE)
 20 education specialist/7-12
 21 outreach coordinator \$



- 1 4. One full-time equivalent (1.0 FTE)
- 2 navigator in residence \$
- 3 5. In-state travel expenses \$
- 4 6. Curriculum materials \$
- 5 7. Computer equipment and furniture \$

6 The sum appropriated shall be expended by the University of
7 Hawaii at Hilo for the purposes of this Act.

8 SECTION 3. This Act shall take effect on July 1, 2014.
